(VARIATION NO. T) ORDER 2026******

The Warwickshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by sections 1(1), 2(1) to (3), 4(2), 19, 32, 35, 45, 46, 47, 49, 53 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act"), the Traffic Management Act 2004, and of all other enabling powers, hereby make the following Order:-

**PART I
CITATION AND INTERPRETATION**

1. The Warwickshire County Council (District of Warwick) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2017 (which said Order of 2017 as varied is hereinafter referred to as 'the Principal Order') is hereby further varied in the manner and to the extent hereinafter provided.
2. In the Principal Order, prior to Article 8B insert the following:-

"8A. Save as provided within Articles 10(1) (c)(ii), (d) and (h) no person shall, except in the case of emergency upon the direction or with the permission of a police constable in uniform or a civil enforcement officer, or when the person in control of the vehicle is required by law to stop or is obliged to stop to avoid an accident or is prevented from proceeding by circumstances outside his control, cause or permit a vehicle to stop in the lengths of road identified on the plans as "no stopping except in an emergency" or "no stopping".
3. In Schedule 2 to the Principal Order, after Plan Title "FX57", replace the revision number with revision number "2".
4. In the Principal Order, replace the plans attached thereto which are listed in column 1 of Schedule 1 below, with the plans attached to this Order and listed in column 2 of Schedule 1 below.
5. Attach the plans listed in Schedule 2 below and attached to this Order to the Principal Order.
6. This Order shall come into operation on the _____ day of _____ Two thousand and twenty-six and may be cited as "The Warwickshire County Council (District of Warwick) (Civil Enforcement Area) (Waiting Restrictions, On-Street Parking Places and Residents' Parking) (Consolidation) (Variation No. T) Order 2026".
