ROAD TRAFFIC REGULATION ACT 1984

THE WARWICKSHIRE COUNTY COUNCIL (VARIOUS ROADS, NORTON LINDSEY)
(20 MPH SPEED LIMIT)
ORDER 2026

1. STATEMENT OF REASONS

- 1.1** Following a request from Cllr Matecki, Warwickshire County Council is proposing to introduce a 20-mph speed limit as shown on the plans attached (**Dwg. No PTRO24/024/001 & PTRO24/024/002**).
- 1.2** Warwickshire County Council is proposing to introduce a 20-mph speed limit on the lengths of road described in Schedule 1 below which are currently 30mph and Schedule 2 below which is currently national speed limit.
- 1.3** The scheme will involve the use of speed reducing traffic signs and road markings within a specific Urban area located in the parish of Norton Lindsey.
- 1.4** As a result of further investigations conducted into the area requested for the speed reduction, results showed that the mean speeds have met the criteria for reducing the speed limit to 20mph without having to install traffic calming measures. In addition, consultations with the Traffic & Road Safety Team and the Police concluded with a recommendation to introduce a 20mph speed limit on the roads detailed in Schedule 1 and 2 below.
- 1.5** The reduced speed limit will help improve the environment for vulnerable road users, such as wheelchair users, horse riders, pedestrians and pedal cyclists as there are no footpaths in the village. The village has a church and a public house which are used by residents and visitors to Norton Lindsey. Motorists will be travelling at a slower speed, and therefore more aware of safety issues when driving through the village.

2. SCHEDULE

SCHEDULE 1

(Existing 30mph to become 20mph Speed Limit)

D5269 Church Road, Norton Lindsey

In its entirety from its junction with Snitterfield Lane.

D5628 Main Street, Norton Lindsey

From its junction with New Road in a northwest direction for 305 metres.

C93 – New Road, Norton Lindsey

From its junction with Main Street northwards for 45 metres.

C93 - Snitterfield Lane, Norton Lindsey

From its junction with Main Street and New Road in a southeast direction for 102 metres.

SCHEDULE 2

(Existing National Speed Limit to become 20mph)

D5270 Canada Lane, Norton Lindsey

For its entire length from its junction with Snitterfield Lane in an eastward direction.

3. EXISTING ORDERS TO BE REVOKED

No orders to be revoked. All roads affected are currently restricted by virtue of parish street lighting or national speed limit without orders.
