**THE WARWICKSHIRE COUNTY COUNCIL (B4111 NUNEATON ROAD/ATHERSTONE
ROAD/MANCETTER ROAD AND C12 WOODFORD LANE/ATHERSTONE ROAD,
MANCETTER/HARTSHILL)
(TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2026**

WHEREAS the Warwickshire County Council ("the Council") as traffic authority for B4111 Nuneaton Road/Atherstone Road/Mancetter Road and C12 Woodford Lane/Atherstone Road, Mancetter/Hartshill is satisfied that traffic on the said roads should be restricted as indicated in the Schedule below by virtue of works proposed to be executed thereon.

NOW THEREFORE the Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984 and all enabling powers, hereby makes the following Order:

1. This order shall come into operation on 16 July 2026 and may be cited as "The Warwickshire County Council (B4111 Nuneaton Road/Atherstone Road/Mancetter Road and C12 Woodford Lane/Atherstone Road, Mancetter/Hartshill) (Temporary Prohibition of Traffic) Order 2026".
2. No person shall cause or permit any vehicle other than an exempted vehicle to use B4111 Nuneaton Road/Atherstone Road/Mancetter Road and C12 Woodford Lane/Atherstone Road, Mancetter/Hartshill as indicated in the Schedule below for a period of 18 months commencing on 16 July 2026, or until the said works are completed, whichever is the earlier.
3. In this Order exempted vehicle means any vehicle being used for or in connection with the said works.
4. The provisions of Article 2 above shall apply only at such times and to such extent as shall be indicated by traffic signs, as authorised by Section 64 of the said Act of 1984.

Schedule

B4111 Nuneaton Road/Atherstone Road/Mancetter Road closed between the entrance to Dobbies Garden Centre and Grange Road/Leathermill Lane.

C12 Woodford Lane/Atherstone Road closed from the entrance to Severn Trent Works to Apple Pie Lane/entrance to Stoneleigh Glebe Farm.
