ROAD TRAFFIC REGULATION ACT 1984

THE WARWICKSHIRE COUNTY COUNCIL (BOROUGH OF NORTH WARWICKSHIRE) **(WAITING RESTRICTIONS AND ON-STREET PARKING PLACES) (CONSOLIDATION)** **(VARIATION NO. EV1) ORDER 2026**

1. BACKGROUND

- 1.1 Following the installation of a number of electric vehicle (EV) charging points across Warwickshire these are now being formalised.

2. STATEMENT OF REASONS

- 2.1 The proposals to formalise existing EV recharging bays, which are not currently enforceable, will provide clear delineation between bays available for use by any vehicles including those with internal combustion engines (ICE) and those for EV charging only; the provision of EV infrastructure having a potential beneficial impact on air quality as well as supporting the authority's Electric Vehicle (EV) Charging Infrastructure Strategy by enhancing EV parking options.
- 2.2 In determining the need to provide parking places for EV vehicles, the Council has considered it necessary for the purpose of preventing congestion of traffic.
- 2.3 In certain locations adjacent parking restrictions will be adjusted provide consistent restrictions on-street for both ICE and EV vehicles, providing clear and straightforward messaging to motorists, and clarity for civil enforcement officers.

3. SCHEDULE

Church Hill, Coleshill (south side)

Electric Vehicles Only Limited Wait 2 hours No Return 4 Hours Mon-Sat 8am-6pm

- (i) from a point 51 metres east of the junction with High Street, eastward for 23.5 metres (7 no. echelon bays)

Church Hill, Coleshill (north side)

Limited Wait 2 hours No Return 4 Hours Mon-Sat 8am-6pm

- (i) from a point 27 metres east of the junction with High Street, eastward for 10.5 metres (3 no. echelon bays)

- (ii) from a point 37.5 metres east of the junction with High Street, eastward for 12.5 metres
- (iii) from a point 60 metres east of the junction with High Street, eastward for 20 metres

No Waiting At Any Time

- (i) from a point 50 metres east of the junction with High Street, eastward for 10 metres

Station Street, Atherstone (south side)

Electric Vehicles Only Limited Wait 2 Hours No Return 4 Hours Mon-Sat 9am-5pm

- (i) From a point 1.5 metre northwest of the property boundary between numbers 73 & 75, north-westward for 11 metres (2 no. bays)
- (ii) From a point 18 metres northwest of the property boundary between numbers 73 & 75, north-westward for 11 metres (2 no. bays)

Limited Wait 2 Hours No Return 4 Hours Mon-Sat 9am-5pm

- (i) from a point 12.5 metres northwest of the property boundary between numbers 73 & 75, north-westward for 5.5 metres
- (ii) from a point 32.5m northwest of the property boundary between numbers 73 & 75, north-westward for 42.5m

No Waiting At Any Time

- (i) from a point 1.5 metres northwest of the property boundary between numbers 73 & 75, south-eastward for 3 metres
- (ii) from a point 29 metres northwest of the property boundary between numbers 73 & 75, north-westward for 3.5 metres
