**THE WARWICKSHIRE COUNTY COUNCIL (BOROUGH OF RUGBY)
(CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS, ON STREET PARKING
PLACES AND RESIDENTS' PARKING) (CONSOLIDATION)
(VARIATION NO. EV1) ORDER 2026**

The Warwickshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by sections 1(1), 2(1) to (3), 4(2), 19, 32, 35, 45, 46, 47, 49, 53 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act"), the Traffic Management Act 2004, and of all other enabling powers, hereby make the following Order:-

**PART I
CITATION AND INTERPRETATION**

1. The Warwickshire County Council (Borough of Rugby) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2017 (which said Order of 2017 as varied is hereinafter referred to as 'the Principal Order') is hereby further varied in the manner and to the extent hereinafter provided.
2. In Article 2 to the Principal Order, after to the definition of "administration fee" insert:-

""all-electric vehicle" means an electrically propelled vehicle where the battery is the only power source which is adapted or suitable for use on a road;"
3. In Article 2 to the Principal Order, after the definition of "charge certificate" insert:-

""charge point" has the same meaning as in the Automated and Electric Vehicles Act 2018;""
4. In Article 2 to the Principal Order, after the definition of "driver" insert:-

""electric vehicle" means either an all-electric vehicle or a plug-in hybrid vehicle;

"electric vehicle parking place" means a road or length of road designated as a parking place for electric vehicles only by Article 13(5);"
5. In Article 2 to the Principal Order, after the definition of "plans", insert the following definition:-

""plug-in hybrid vehicle" means a hybrid vehicle which can switch between running on electricity or fossil fuels and which is capable of connecting via a lead to a charge point;"

6. After Article 13(4) to the Principal Order, insert the following:-

“(5) Subject to the following provisions of Articles 14 to 21, the parts of roads identified on the plans as parking places for Electric Vehicles Only are authorised to be used as parking places in such positions, on such days and during such hours as identified on the plans, for electric vehicles only PROVIDED THAT such electric vehicles when parked in an electric vehicle parking place are connected to a charge point via a charging lead for the purposes of recharging the battery of the electric vehicle or the plug-in hybrid vehicle.”

7. After Article 20 to the Principal Order, insert:-

“20A The driver of a vehicle shall not permit the vehicle to wait in an electric vehicle parking place unless that vehicle is an electric vehicle which is connected to a charge point via a charging lead for the purposes of recharging the battery of the electric vehicle.”

8. In Schedule 2 to the Principal Order, after Plan Title “EO97”, replace the revision number with revision number “2”.

9. In Schedule 2 to the Principal Order, after Plan Title “EJ97”, replace the revision number with revision number “6”.

10. In Schedule 2 to the Principal Order, after Plan Title “EL97”, replace the revision number with revision number “3”.

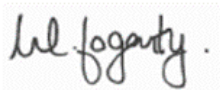
11. In the Principal Order, replace the plans attached thereto which are listed in column 1 of Schedule 1 below, with the plans attached to this Order and listed in column 2 of Schedule 1 below.

12. This Order shall come into operation on the 7th day of September Two Thousand and Twenty-Six and may be cited as “The Warwickshire County Council (Borough of Rugby) (Civil Enforcement Area) (Waiting Restrictions, On-Street Parking Places and Residents’ Parking) (Consolidation) (Variation No. EV1) Order 2026”.
