I hereby apply for an Order under Section 53(2) of the Wildlife and Countryside Act 1981
modifying the Definitive Map and Statement for the County of Warwick by **Upgrading -**

Please describe the route carefully and explain exactly where the route starts (from a point on a road or path), the line it follows and exactly where it finishes. Description:

R128 runs from the west (Lawford Heath Lane) to the east (Bilton Lane). It is approx. 1/2 mile in length and averages 21 ft in width and is approx. 27 ft at its widest (mid-way). The track is both hedged and fenced on both sides and runs virtually in a straight line.

At the west end surface materials are cobble/hardcore, well used by farm vehicles with a double wheel track, wide grass verges on both sides and central grassy track. From the eastern end the surface is tarmac extending up to the last (third) driveway to "Gillings" (Bilton end). The track is virtually overgrown along the boundary of "Gillings" and the existing pathway runs along what was once the grass verge. At the eastern (Bilton) end of the track there is a padlocked farm gate and a very narrow pedestrian gate with a concrete post set behind it to limit its opening width.

Immediately after the padlocked gate the hedge has almost completely overgrown and the track narrows to approx. 3' in places, and for a short distance beyond this overgrowth the grass has consequently over-run the track for a short distance when travelling west.

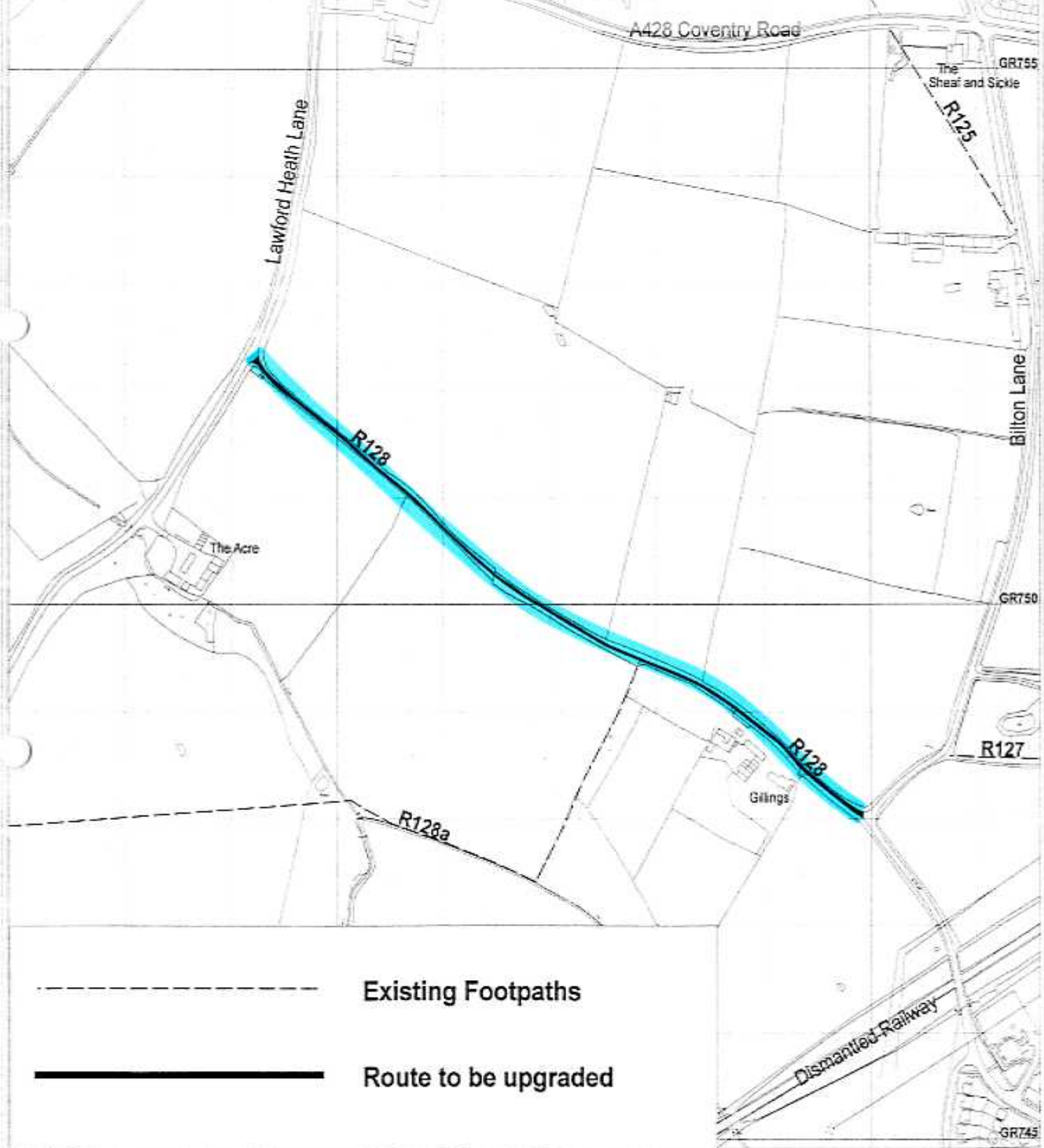
