THE SURFACE HERE IS OF COMPACTED EARTH AND SOME 10 METRES WIDE AT 0.1KM THERE IS A GATE THE ROUTE IS HEDGED UP TO 0.3KMS WHERE THERE IS ANOTHER GATE AND A HEDGE ON ONE SIDE TO ANOTHER GATE AT 0.6KMS IT THEN FOLLOWS THE FENCE LINE ONTO THE CATTORPE TO SHIWELL ROAD THE SURFACE IS MOSTLY PADDLED GRASS TOTAL LENGTH 1.KM. SEE ENCLOSED PHOTOGRAPHS AND DETAILS
