R75. PASSING WALSGRAVE HILL TO THE SOUTH AND WALSGRAVE HILL FARM  
TO THE NORTH AND ONTO HILL FIELDS FARM WHERE IT TURNS SOUTHEAST  
THROUGH THE FARM THEN EASTWARDS UNTIL ITS JUNCTION WITH  
R75 6 AND ONTO THE COUNTY ROAD THE D2045.

THERE IS A FARM AND A SMALL GATE AT THE FARBER ROAD END  
AND THE SURFACE IS OF ROUGH CONCRETE SOME 10 FEET WIDE  
AT THE TURN OFF TO WALSGRAVE HILL FARM THE ROUTE BECOMES  
A DIRT TRAIL UP TO HILL FIELDS FARM WHERE THERE IS ANOTHER  
GATE IT THEN BECOMES A ROUGH TARMACK SOME 16 FEET WIDE  
WITH SMALL SPEED HUMPS.

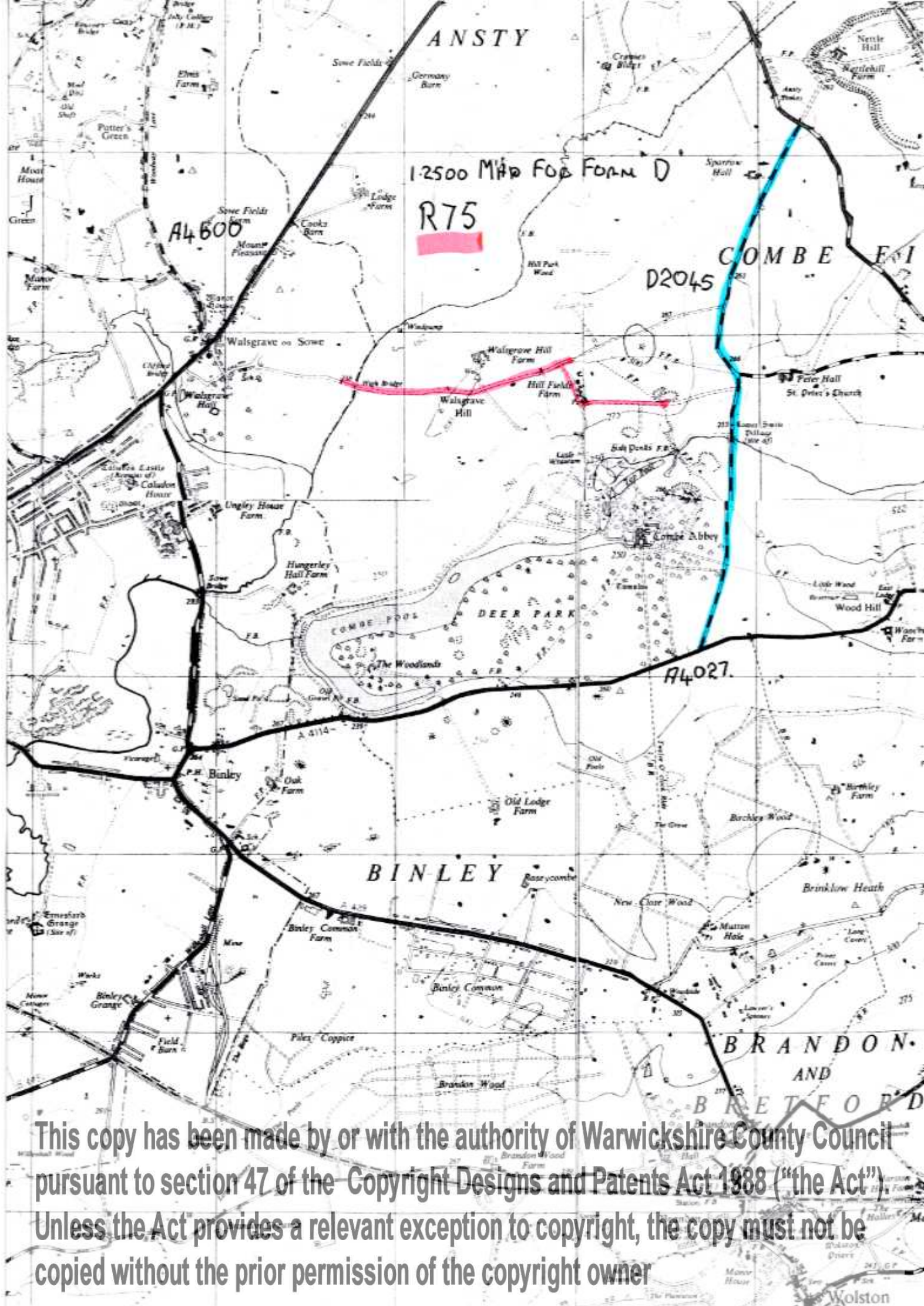
