Description : **R78d FROM THE H42S. THE TRACK IS 4 TO 5 METRES WIDE WITH A GOOD HARD BUT BROKEN METTLE SURFACE, BETWEEN ITTAGES. IT IS 0.5 OF A MILE LONG. THE SURFACE IS SOME 3 METRES WIDE WITH A HARD STONEY SURFACE CONTINUING UP THE HILL 17M FROM THIS POINT. THE PATH BECOMES 1.62 METRES WIDE TO ANOTHER GATE SOME 0.8 OF A MILE FROM THE START THEN WITH A HEDGE ON ONE SIDE AND 17 POST AND RAIL FENCE ON THE OTHER. AFTER ANOTHER GATE IT IS SOME 0.57 OF A MILE LONG CONTAINING IN A PADDLED GRASS SURFACE TO THE R78b SECTION. TOTAL LENGTH OF TRACK 1 MILE**
