**THE ROUTE STARTS AT THE D2066 CATHIRON LANE WITH A STONY TRACK LEADING TO THE CANAL BRIDGE SOME 8 FEET WIDE AT THIS POINT. IT THEN RUNS UNDER THE RAILWAY BRIDGE AND THROUGH A WOODED AREA. CATHIRON SPINNEYS TO A GATE. IT THEN WIDENS UP INTO A Paddock TYPE AREA TO A SECOND GATE. WHICH OPENS UP TO A 20 FOOT WIDE STONY TRACK PAST LILAC COTTAGE ONTO THE C129 EASENHALL ROAD NEAR TO THE JUNCTION WITH THE D2065. TOTAL LENGTH SOME 1 TO 1.5 MILES. LONG.**

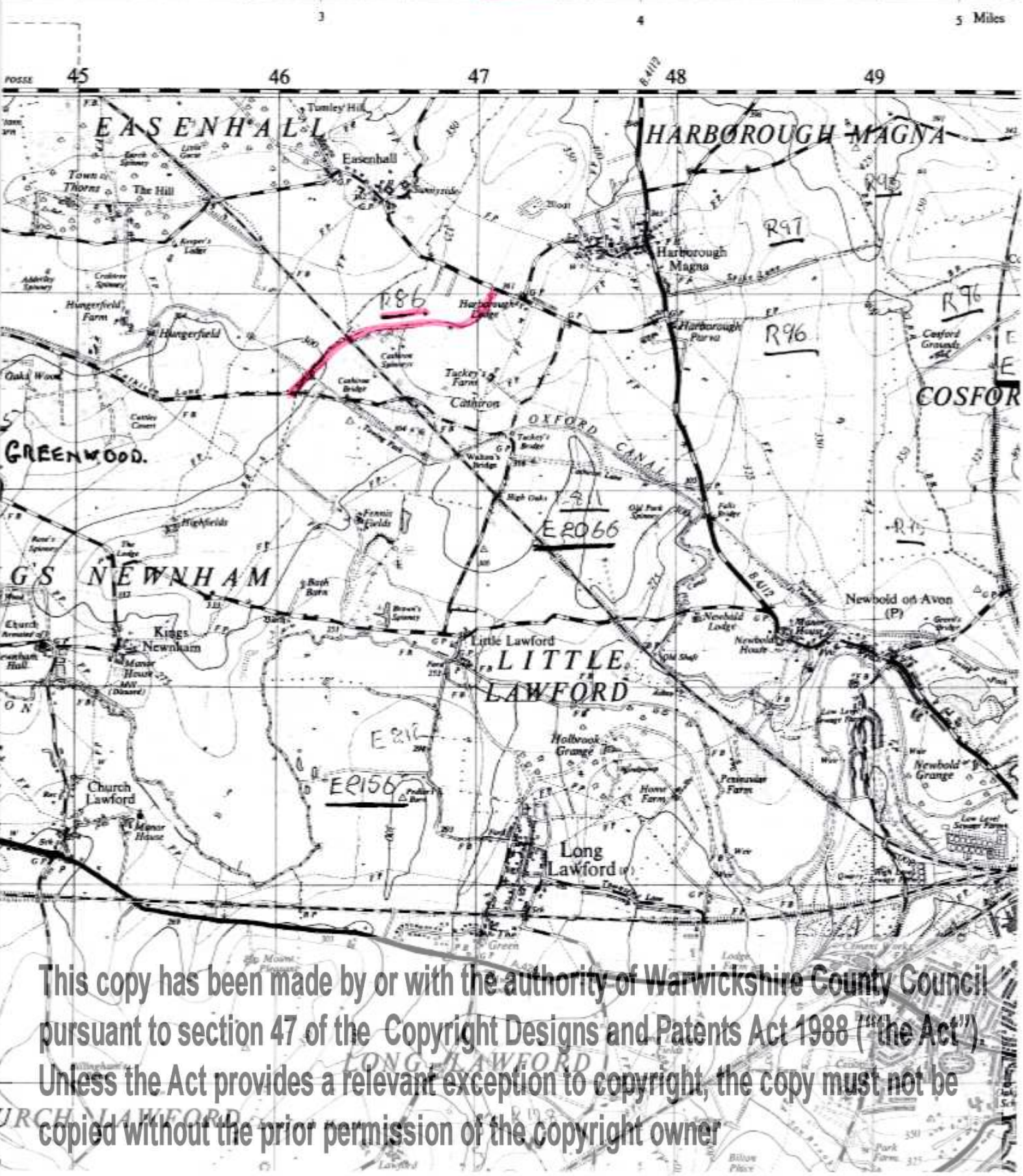
