Description :

A110a leaves the county road C39 (Burford Lane) opposite county road D5349 at Grid Ref. 1130 – 6225 on the definitive map SP16SW. Then along the line of county road E5997 for 750 metres in a northerly direction. It continues for a further 700 metres to join the county road C46 at Grid Ref. 1095 – 6365. The E road section of the route is some 5 metres wide with overgrown vegetation and encroaching hedges. From the end of the E road the route follows a tree line to the left to a sunken lane at Grid.Ref. 1160 – 6335. After this the lane is more open to its end adjacent to Green Hill Farm.
