I hereby apply for an Order under Section 53(2) of the Wildlife and Countryside Act 1981  
modifying the Definitive Map and Statement for the County of Warwick by **Upgrading** -

from a Public Footpath / Bridleway\*

Please describe the route carefully and explain exactly where the route starts (from a point on a road or path), the line it follows and exactly where it finishes. Description :

AL111 leaves the county road C46 at Grid Ref. 1100 – 6370 on the definitive map SP16 SW for 500 metres to join SD197 at Grid Ref. 1150 – 6375 then on for a further 800 metres in an easterly direction to Grid Ref. 1227 – 6395 and the county road D5215. From the start of the route, it is some 4 to 5 metres wide between hedges, to a gate into a ploughed field. The route is well defined in a straight line across this field to another gate, then back into a wide hedged lane with one more gate and a 2 posts marker onto the county road D5215.

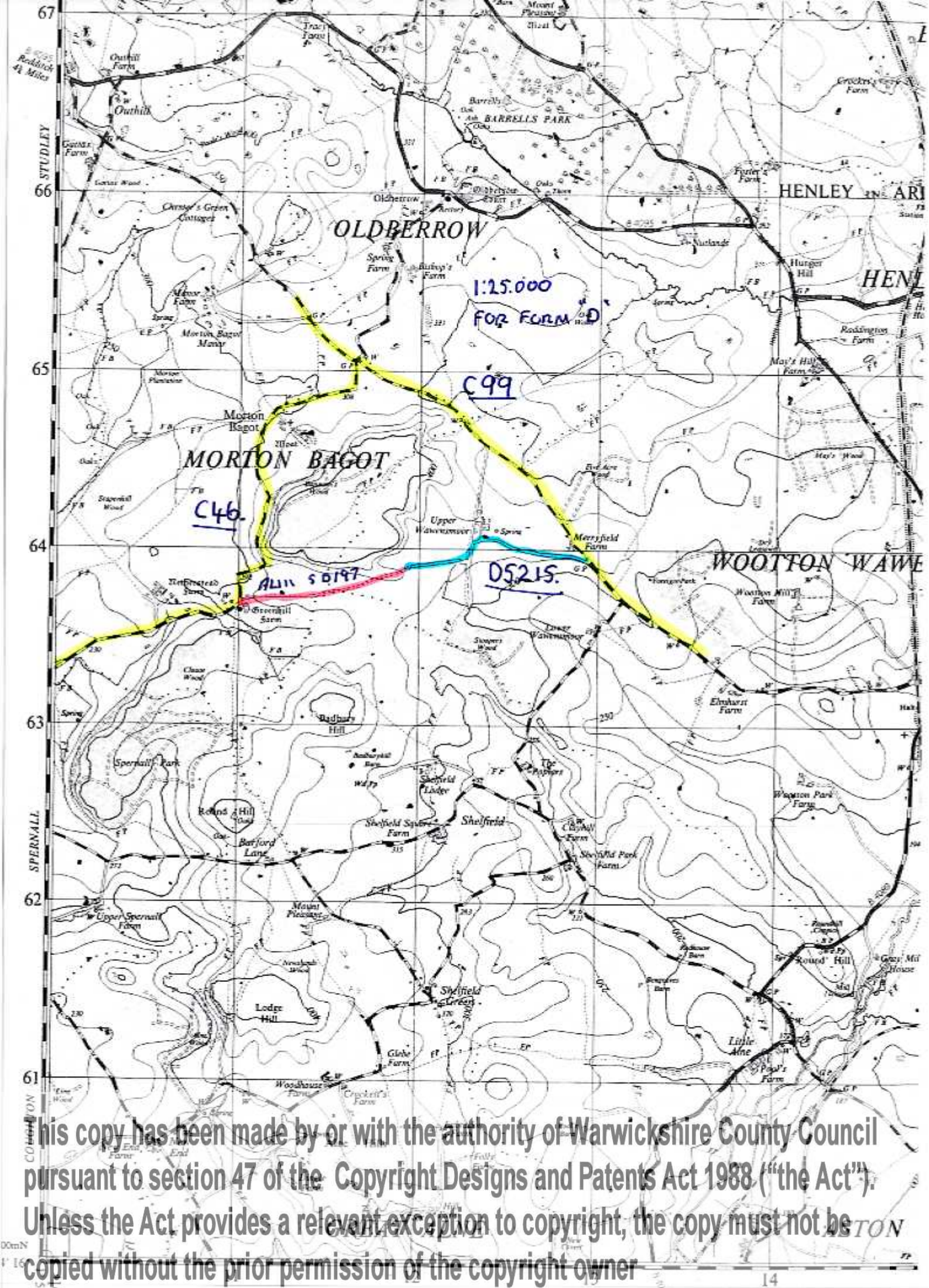
