Statement of Evidence for Alcester Claim No.17

- 1) The claimed route is first recorded on a map of the Throckmorton Estate dated 1746 (County Record Office CR1998/11) where it is shown as being an integral part of the road network of the parish, not being separated from the linking roads at either end and all being coloured in the same way.
- 2) The route is shown on all the relevant Ordnance Survey maps from the first edition of the one inch to one mile map of 1831 (sheet 51, Worcester) to the present day.
- 3) The status of the route is established by two deposited railway plans. The first is that of the proposed Midland Railway, Birmingham and Gloucester Branches (line from Cofton Hacket to Coughton) 1845 (QS111/165). This lists the claimed route as : 39 "Public Highway", with the owner being given as the Surveyor of Highways in Coughton.
- 4) The second plan is that of the Evesham and Redditch Railway 1862 (QS111/248). This shows most of the claimed route where it is numbered 364 and listed as "Road", with the owner being the Surveyor of Highways.
- 5) The map for the Finance Act 1910 shows the west part as being excluded from the adjoining hereditaments, but the east part as passing through hereditaments 184, 159 and 190 (the railway). The 'Forms 37 – Land' are not available for this parish. (They have, apparently, only been sorted in to parishes up to K: Kenilworth.)
