

## NOTICE OF CONFIRMATION OF AN ORDER

### HIGHWAYS ACT 1980

#### WARWICKSHIRE COUNTY COUNCIL

#### (PART OF FOOTPATH R89 HARBOROUGH MAGNA) PUBLIC PATH DIVERSION ORDER 2020

On 20 October 2020 Warwickshire County Council confirmed the above Order made under Section 119 of the Highways Act 1980.

The effect of the Order as confirmed will **DIVERT** the full length and width of that section of Public Footpath R89 from Point A through the domestic gardens of Le Verger and the dwelling of Campden (grid reference 447549 – 279311) to point B (grid reference 447517 – 279388) a total distance of approximately 86 metres as shown on the Order Plan, **TO A LINE** from Point A (grid reference 447549 – 279311) running generally East for approximately 30 metres to Point C (grid reference 447582 – 279317), before continuing generally North-north west for approximately 87 metres to point D (grid reference 447555 – 279402) a total distance of approximately 117 metres as shown on the Order Plan. The new route shall have an available width of 3 metres.

A copy of the Order as confirmed and the Order Plan have been placed and may be seen free of charge at the offices of Warwickshire County Council, Shire Hall, Market Square, Warwick CV34 4SA from 8am - 5.30pm on weekdays, (5pm Fridays) and 9am - 4pm Saturdays. A copy of the Order and Order Plan may be bought there at the price of £5.77. Copies may also be inspected at the offices of the Rugby Borough Council, Town Hall, Evreux Way, Rugby, CV21 2RR between 9.00am and 5.00pm Monday - Friday and online at [www.warwickshire.gov.uk/pathorders](http://www.warwickshire.gov.uk/pathorders).

The Order comes into force on 27 October 2020 but if a person aggrieved by the order wants to question its validity or that of any provision contained in it, on the ground that any requirement of the Act, as amended, or if any regulation made under the Act has not been complied with in relation to the order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 22 October 2020 make an application to the High Court.

This Order is made by Warwickshire County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the path should be diverted.

Mr & Mrs Lawrence have agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Rugby Borough Council has been consulted as required by section 120(2) of the 1980 Act;

**BY THIS ORDER:**

1. The public right of way over the land situate at **Harborough Magna** and shown by a bold continuous line on the plan numbered R89/SC2019 contained in this Order ('the Order Plan') and described in Part 1 of the Schedule to this Order shall be stopped up upon the issue by the authority of a written certificate to certify that the new route is fit for public use and works to implement the Order have been satisfactorily complied with.
2. There shall at the end of 7 days from the date of confirmation and the issue by the authority of a written certificate that all works to implement the Order have been satisfactorily completed be a Public Footpath over the land situate at **Harborough Magna** described in Part 2 of the Schedule and shown by a bold broken line on the Order Plan.
3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

**PART 1**  
**DESCRIPTION OF SITE OF EXISTING PATH OR WAY**  
**Between Points A and B on the Order Plan**

That section of Public Footpath R89 from Point A through the domestic gardens of Le Verger and the dwelling of Campden (grid reference 447549 – 279311) to point B (grid reference 447517 – 279388) a total distance of approximately 86 metres as shown on the Order Plan.

**PART 2**  
**DESCRIPTION OF SITE OF NEW PATH OR WAY**  
**Between Points A, C and D on the Order Plan**

From Point A (grid reference 447549 – 279311) running generally East for approximately 30 metres to Point C (grid reference 447582 – 279317), before continuing generally North-north west for approximately 87 metres to point D (grid reference 447555 – 279402). a total distance of approximately 117 metres as shown on the Order Plan.

The new route shall have an available width of 3 metres.

**PART 3**  
**LIMITATIONS AND CONDITIONS**

A kissing gate will be installed at termination point D.

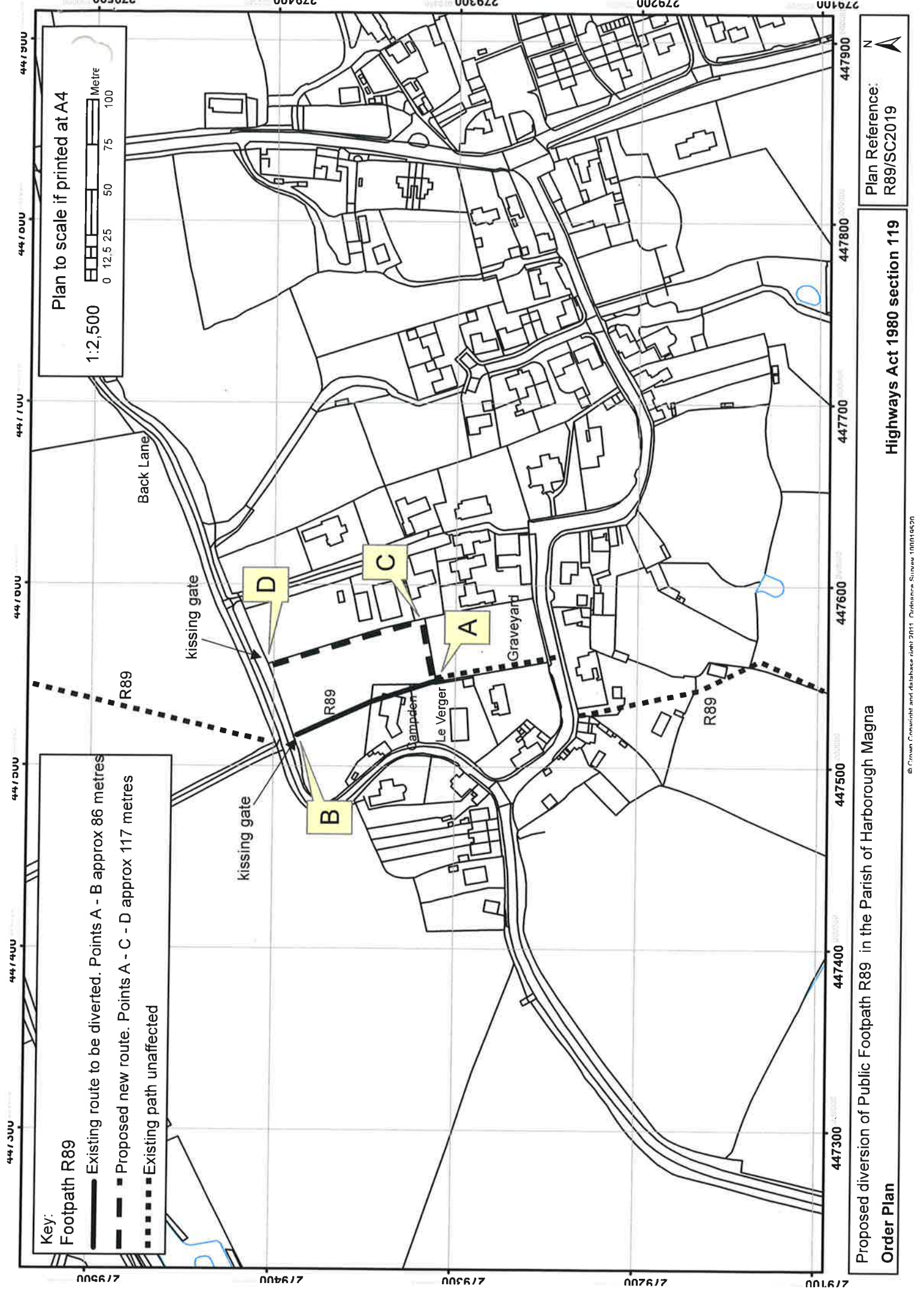
