The new route shall have a width of 2 metres.

If no such representations or objections are duly made, or if any so made are withdrawn, Warwickshire County Council may confirm the Order as unopposed Order. If the Order is sent to the Secretary of State for the Environment, Food and Rural Affairs for confirmation any representations and objections which have not been withdrawn will be sent with the Order.

This Order is made by Warwickshire County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the path should be diverted.

Coleshill Town Council have agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

North Warwickshire Borough Council has been consulted as required by section 120(2) of the 1980 Act;

BY THIS ORDER:

- 1. The public right of way over the land situate at Coleshill and shown by a bold continuous line on the plan numbered M67/SC2020 contained in this Order ('the Order Plan') and described in Part 1 of the Schedule to this Order shall be stopped up upon the issue by the authority of a written certificate to certify that the new route is fit for public use and works to implement the Order have been satisfactory complied with.
- 2. There shall at the end of 7 days from the date of confirmation and the issue by the authority of a written certificate that all works to implement the Order have been satisfactorily completed be a Public Footpath over the land situate at Coleshill described in Part 2 of the Schedule and shown by a bold broken line on the Order Plan.
- 3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

SCHEDULE

PART 1 DESCRIPTION OF SITE OF EXISTING PATH OR WAY Between Points A - C on the Order Plan

That section of Public Footpath M67 from Point A (grid reference 420310-288941) to point C (grid reference 420377-288900) a total distance of approximately 78 metres as shown on the Order Plan.

PART 2 DESCRIPTION OF SITE OF NEW PATH OR WAY Between Points A – B - C on the Order Plan

From Point A (grid reference 420310-288941) running generally East to Point B (grid reference 420358-288952) before continuing generally South to point C (grid reference 420377-288900), a total distance of approximately 102 metres as shown on the Order Plan.

The new route shall have an available width of 2 metres.

PART 3 LIMITATIONS AND CONDITIONS


A DDA compliant kissing gate will be installed at point A.
