

## **NOTICE OF MAKING OF AN ORDER**

### **HIGHWAYS ACT 1980**

#### **WARWICKSHIRE COUNTY COUNCIL**

##### **(PART OF FOOTPATH SD295 TAMWORTH IN ARDEN) PUBLIC PATH DIVERSION ORDER 2008**

On 25 August 2021 Warwickshire County Council confirmed the above Order made under section 119 of the Highways Act 1980.

The effect of the Order as confirmed is to DIVERT Public Footpath SD295 Tanworth in Arden from Point A (grid reference 413643 272845) running generally north east for approximately 108 metres to Point B (grid reference 413690 272940) TO A LINE: From Point A (grid reference 413643 272845, running generally east for approximately 7 metres, then generally north east for approximately 80 metres, then generally north east for approximately 10 metres, then generally north east for approximately 20 metres to Point C (grid reference 413704 272937) as shown on the Order Plan. The new route shall have a width of 3 metres

A copy of the Confirmed Order and Plan have been placed and may be seen free of charge at the offices of Warwickshire County Council, Shire Hall, Market Square, Warwick CV34 4SA from 8am - 5.30pm on weekdays, (5pm Fridays) and 9am - 4pm Saturdays. The Order comes into force on 1 September 2021 but if a person aggrieved by the order wants to question its validity, or that of any provision contained in it, on the ground that any requirement of the Act, as amended, or if any regulation made under the Act has not been complied with in relation to the order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from (as per advertising date), make an application to the High Court.

This Order is made by Warwickshire County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the path should be diverted.

**Elizabeth Shill** has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Stratford on Avon District Council has been consulted as required by section 120(2) of the 1980 Act;

**BY THIS ORDER:**

1. The public right of way over the land situate at **Tanworth in Arden** and shown by a bold continuous line on the plan numbered P2006/026E/1 contained in this Order ('the Order Plan') and described in Part 1 of the Schedule to this Order shall be stopped up upon the issue by the authority of written certification that all of the work described in Part 4 of the Schedule has been satisfactorily completed.
2. There shall at the end of 7 days from the date of confirmation of this Order be a public footpath over the land situate at **Tanworth in Arden** described in Part 2 of the Schedule and shown by a bold broken line on the Order Plan.
3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

**SCHEDULE**

**PART 1**  
**DESCRIPTION OF SITE OF EXISTING PATH OR WAY**  
**Between Points A and B on the Order Plan**

That section of Public Footpath SD295 from Point A (grid reference 413643 272845), running generally north north east for approximately 108 metres, to Point B (grid reference 413690 272940) as shown on the Order Plan.

**PART 2**  
**DESCRIPTION OF SITE OF NEW PATH OR WAY**  
**Between Points A and C on the Order Plan**

From Point A (grid reference 413643 272845), running generally east for approximately 7 metres, then generally north north east for approximately 80 metres, then generally north east for approximately 10 metres, then generally north north east for approximately 20 metres, to Point C (grid reference 413704 272937) as shown on the Order Plan.

The new route shall have a width of 3 metres.

**LIMITATIONS AND CONDITIONS**

There are no limitations or conditions.

**PART 4**  
**DESCRIPTION OF WORK REQUIRED TO BRING THE SITE OF THE NEW PATH OR**  
**WAY INTO A FIT CONDITION FOR USE BY THE PUBLIC**

A bridge shall be constructed over the ditch at Point A, and a gap of 3m shall be created in the hedge at Point C.

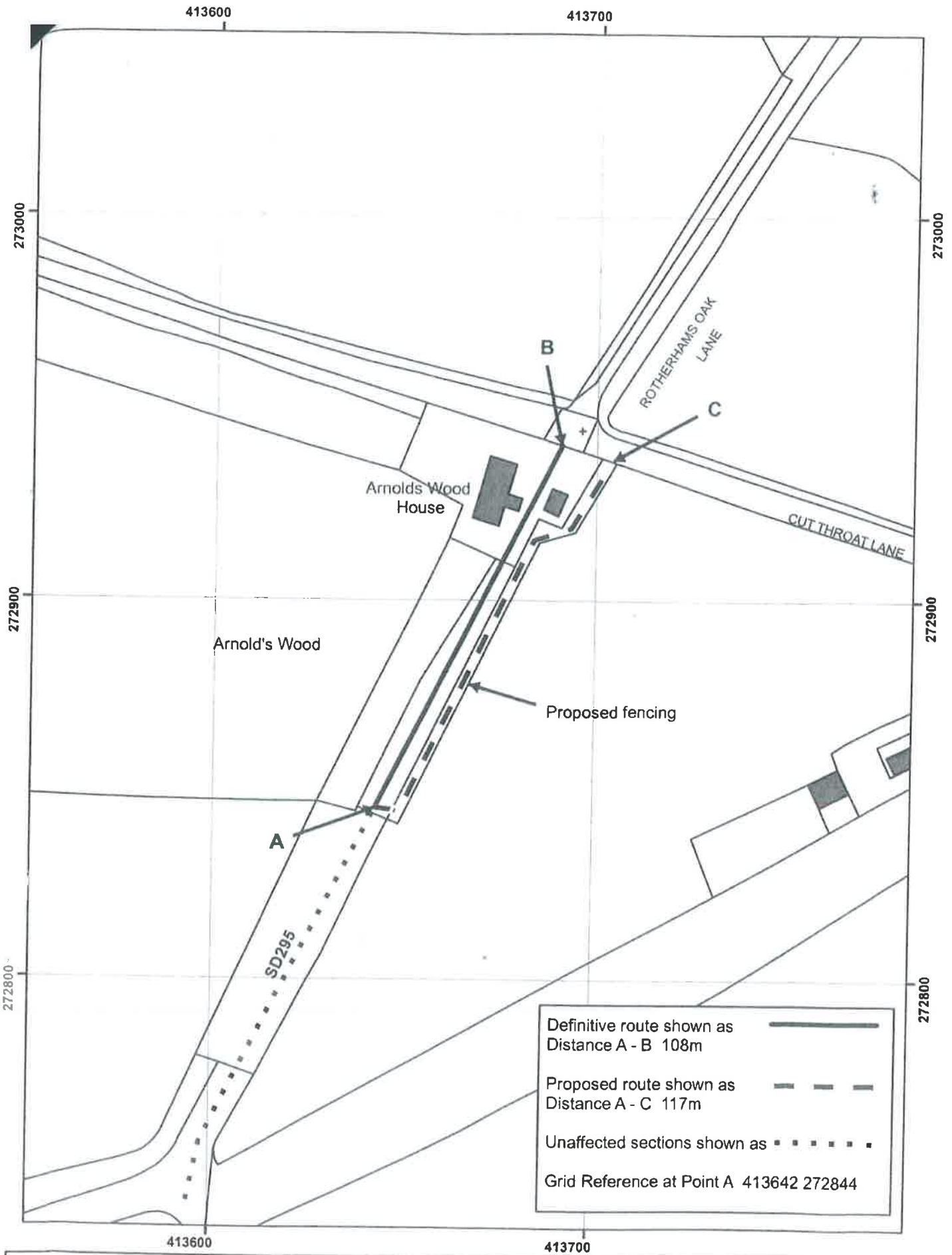

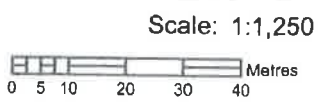
