modifying the Definitive Map and Statement for the County of Warwick by **Upgrading** -

IT RUNS FOR SOME 700 METRES IN A SOUTH EASTERLY DIRECTION TO GRID REF: 3340-5385. THEN IN A NORTH EASTERLY DIRECTION FOR A FURTHER 400 METRES TO ITS JUNCTION WITH SM 78 AT GRID REF: 3410-5415.

THE ROUTE IS SOME 4 TO 5 METRES WIDE THROUGH OUT WITH A PAVED GRASS SURFACE ON LEVEL GROUND AND BETWEEN HEDGES AND WOODLAND

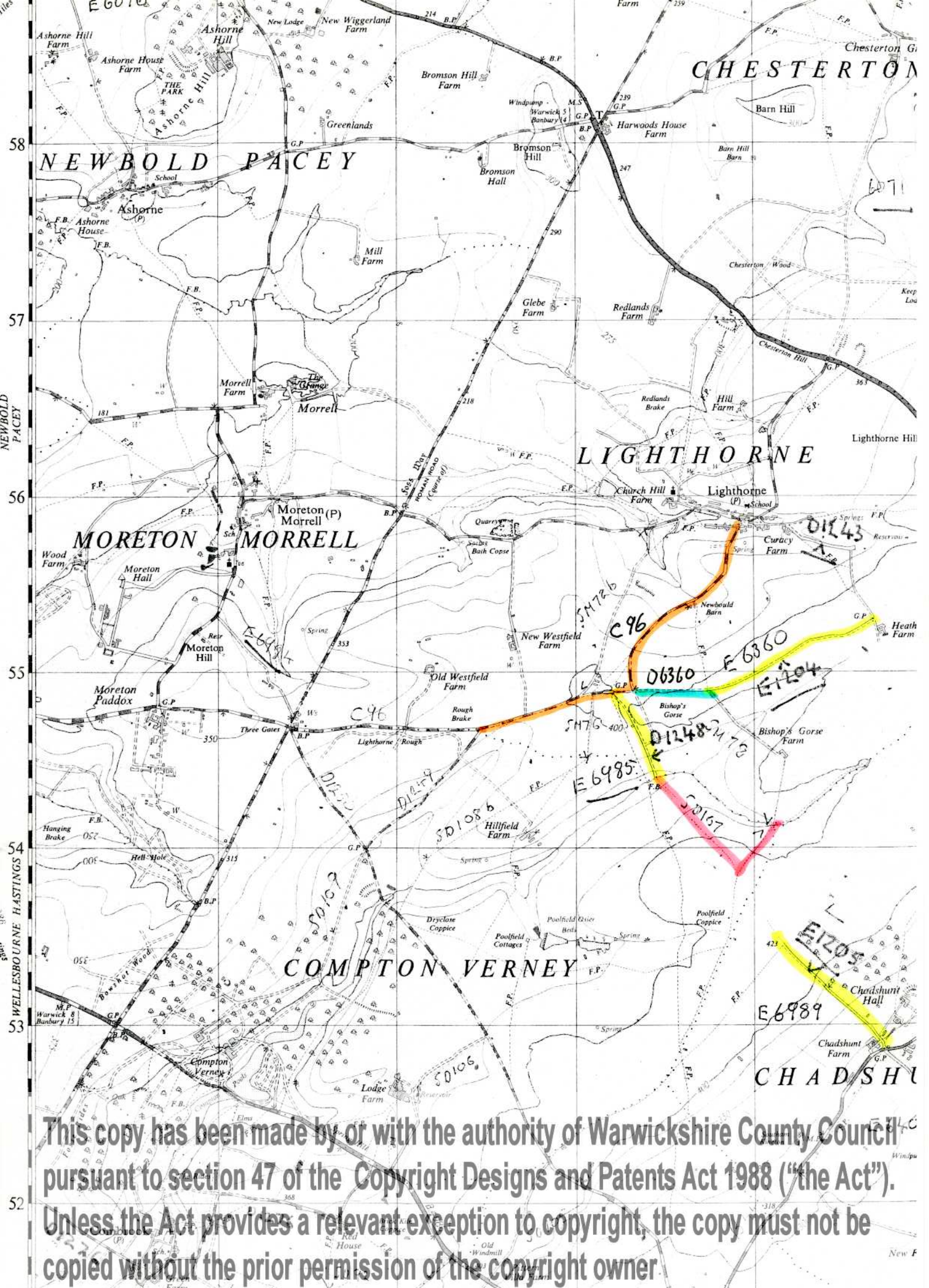
