SD342 on definitive map SP16 NW starts in the west from halfway up Hercules Lane at Grid Ref. 1910 – 6557 and goes in a south easterly direction for some 600 metres to its junction with Lye Green Road the C25. It has an earth surface some 5 metres wide but is overgrown with vegetation and encroaching hedges. N.B. SD342 was known as Rookery Lane in the 1920's.

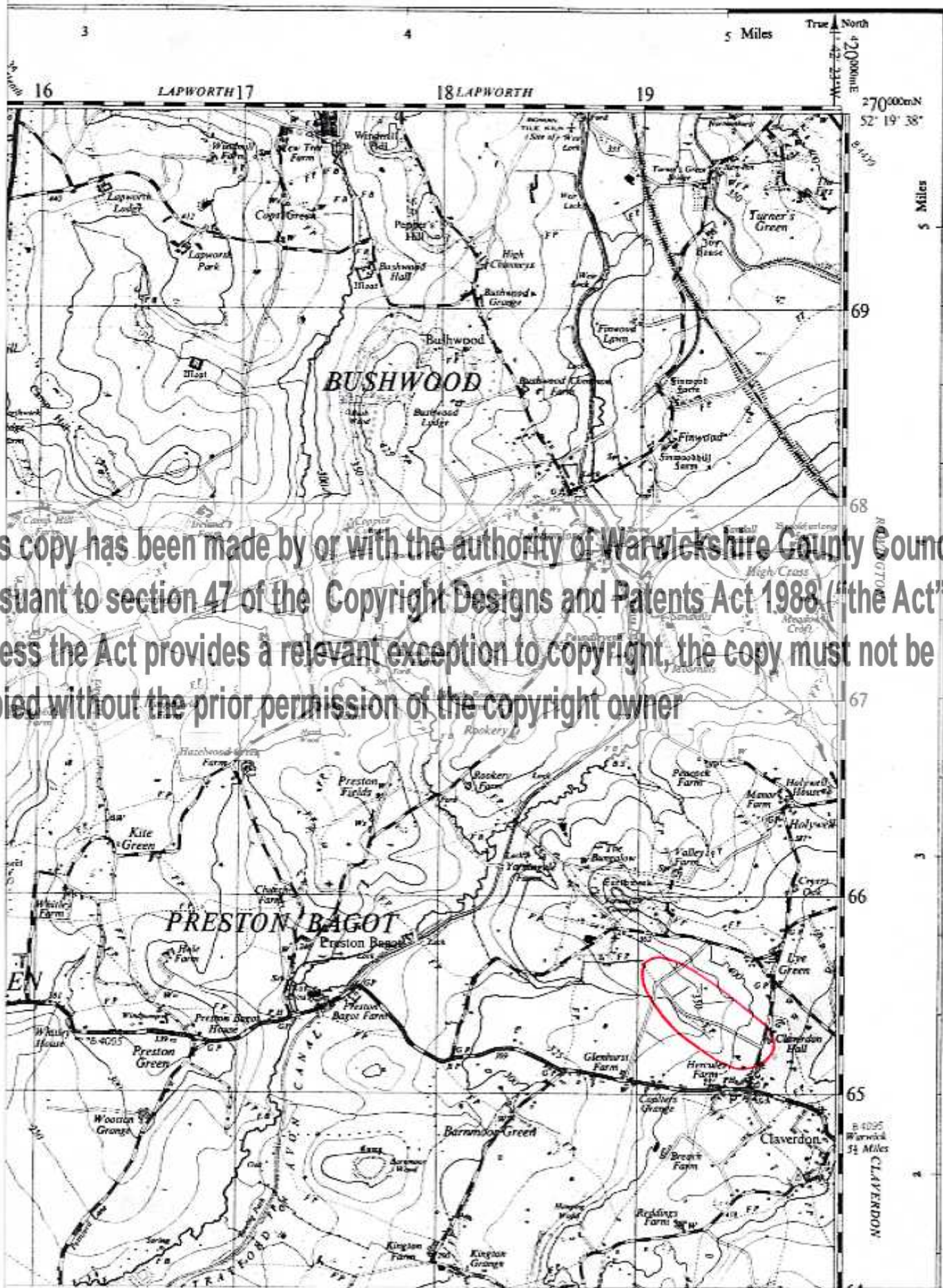
