Description: *SD 1086 2576 ON THE DEFINITIVE MAP SP353W STARTS FROM THE COUNTY ROAD C46 LIGHTHORNE AT GRID REF 3310-5487 THEN IN A SOUTH WESTERN DIRECTION FOR SOME 1.7 KILOMETRES TO THE COUNTY ROAD D6363 AT GRID REF 3200-5363. THE AVERAGE WIDTH BEING 12 TO 5 METRES. THE FIRST 400 METRES SURFACE IS GRASS SEEDLINGS HERD AND HORSES, THEN FOR SOME 450 METRES ACROSS OPEN FIELD TO A SECTION HERDED ON ONE SIDE THE OTHER SECTION OPEN. THE HERDING ROAD IS OPEN HORSE AND CATTLE FIELD. THE ROUTE IS WELL DEFINED THROUGHOUT.*

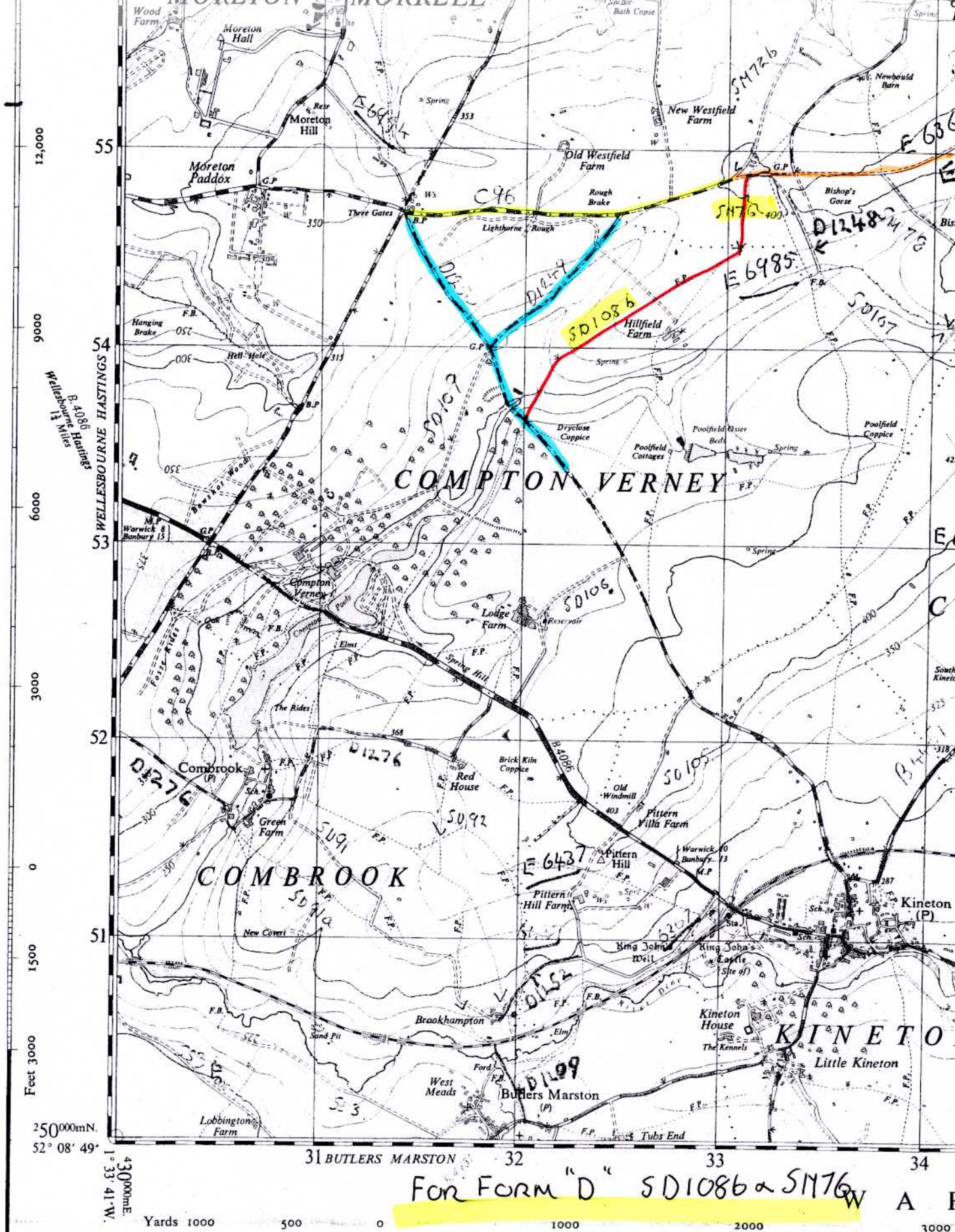
