Description:

W147 is on the definitive maps SP36NW and SP46NW. From the county road B4455 at EATHORPE at grid ref, 3933-6908. The west end and extends for some 1.4 Kilometres to Marton at the eastern end to grid ref, 4065-6876. The route is hedged and fenced though out and is some 4 to 5 metres wide overall the first parts at EATHORPE and MARTON are farmae but the majority of the surface is a hard stone one. There is a locked gate at the MARTON end and a single bollard at the EATHORPE end there is obvious evidence of vehicular use.

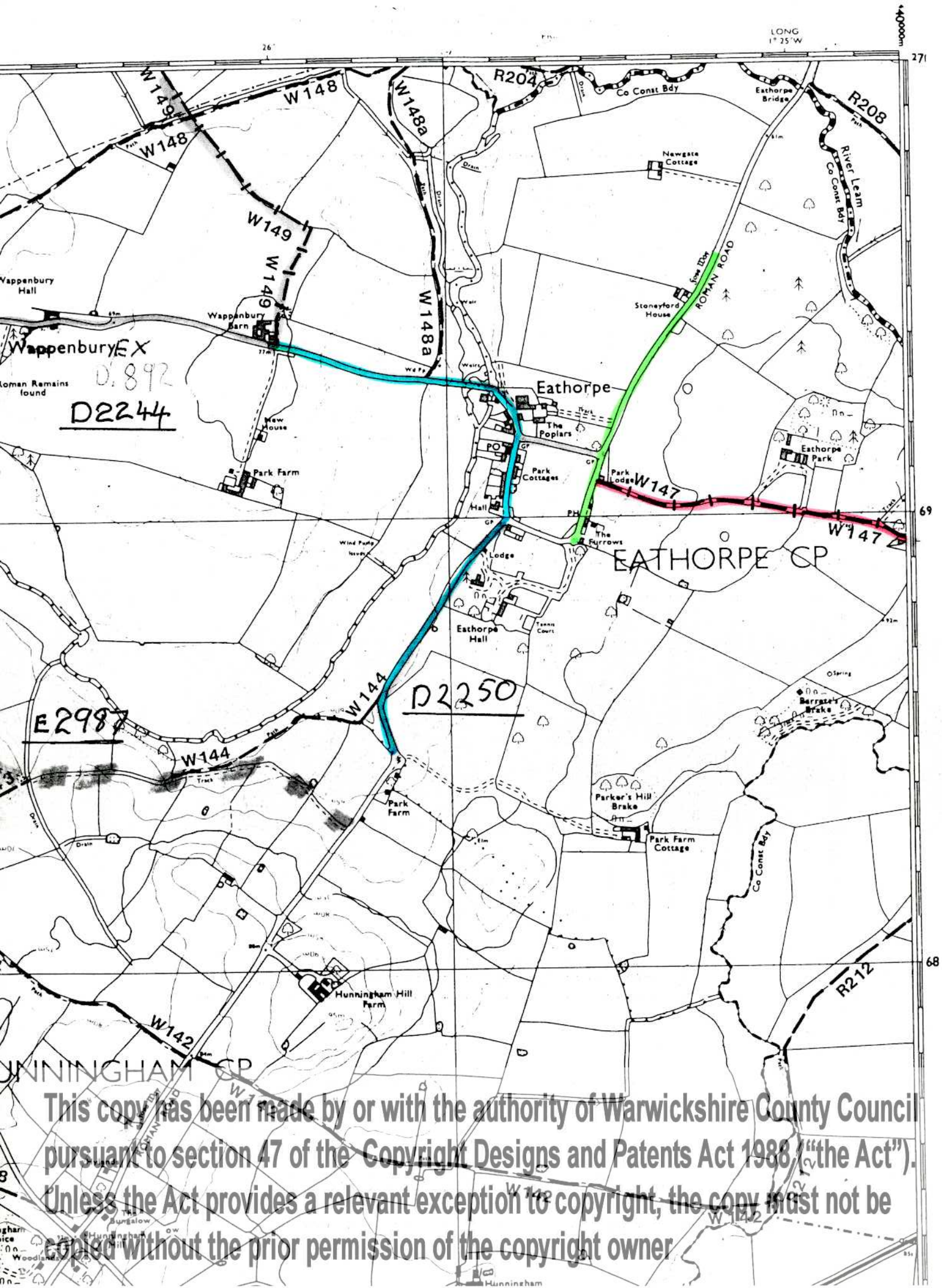

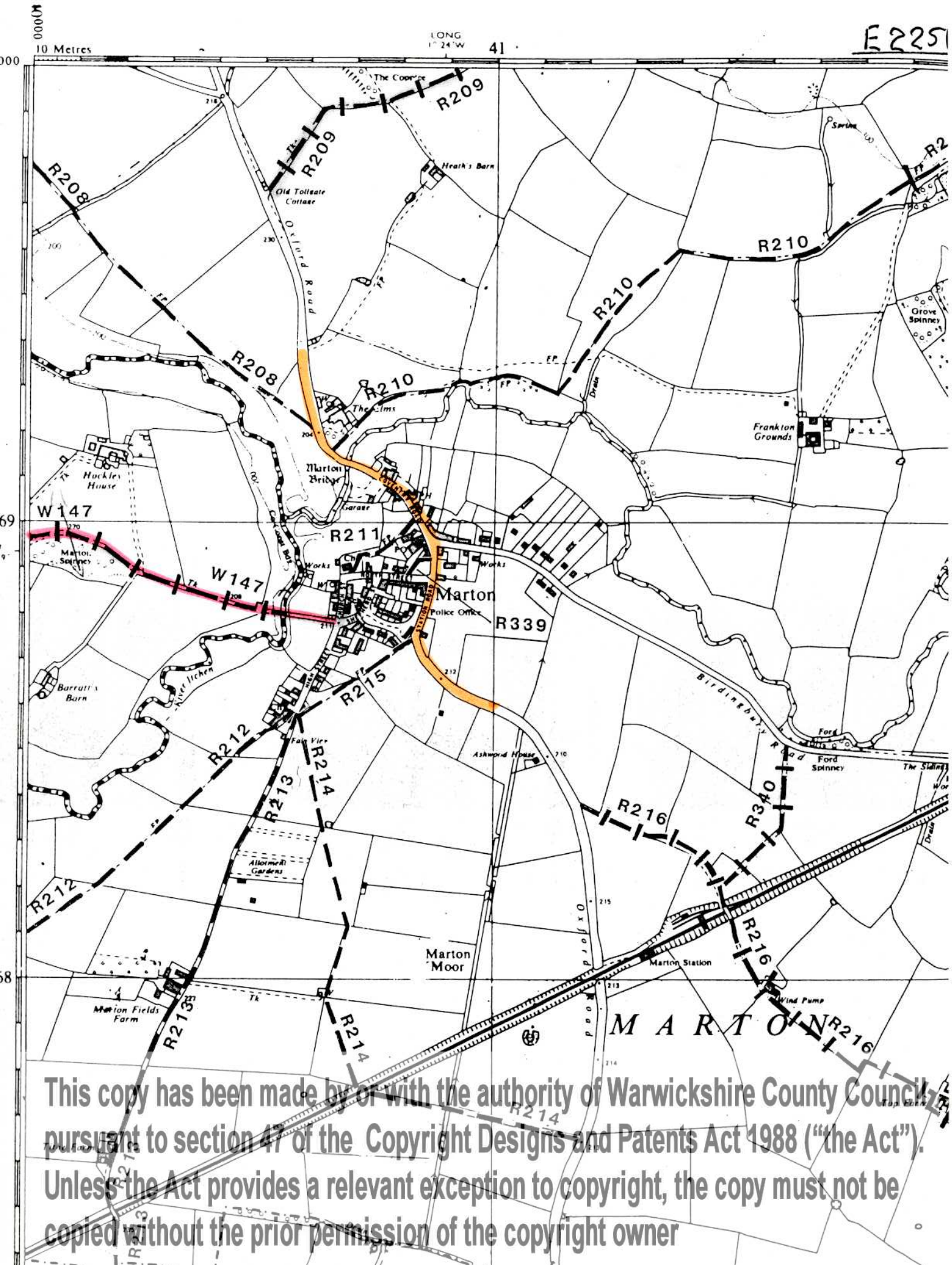
PLAN 1804. PLAN OF ALLOTMENTS AND INCUMBERT
