### (PART OF FOOTPATH AL28&SD23a BIDFORD ON AVON) PUBLIC PATH DIVERSION ORDER 2022

This Order is made by Warwickshire County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the path should be diverted.

Mr Jack Broadhurst and Ms Laura Coles has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Stratford District Council has been consulted as required by section 120(2) of the 1980 Act;

#### BY THIS ORDER:

- 1. The public right of way over the land situate at **Bidford on Avon** and shown by a bold continuous line on the plan numbered AL28&SD23a/SC2022 contained in this Order ('the Order Plan') and described in Part 1 of the Schedule to this Order shall be stopped up upon the issue by the authority of a written certificate to certify that the new route is fit for public use and works to implement the Order have been satisfactory complied with.
- 2. There shall at the end of 7 days from the date of confirmation and the issue by the authority of a written certificate that all works to implement the Order have been satisfactorily completed be a Public Footpath over the land situate at **Bidford on Avon** described in Part 2 of the Schedule and shown by a bold broken line on the Order Plan.
- 3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

#### **SCHEDULE**

# PART 1 DESCRIPTION OF SITE OF EXISTING PATH OR WAY Between Points A – B – C - D – E on the Order Plan

That section of Public Footpath AL28 & SD23a from points A (Grid reference 411600 – 251717 to point B (Grid Reference 411903 – 251754) to point C (Grid Reference 411914 – 251765) to point D (Grid Reference 412112 – 251825) to point E (Grid Reference to 412089 - 251929), a total distance of approximately 632 metres as shown on the Order Plan.

## PART 2 DESCRIPTION OF SITE OF NEW PATH OR WAY Between Points A – G – F on the Order Plan

From Point A (grid Reference 411600 - 251717) running generally west to Point G (grid reference 411513 - 251717) before continuing generally north to point F (grid reference 411495 - 252017), a total distance of approximately 390 metres as shown on the Order Plan.


The new route shall have an available width of 2 metres.
