(PART OF FOOTPATH T9 MIDDLETON) PUBLIC PATH DIVERSION ORDER 2023

This Order is made by Warwickshire County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the path should be diverted.

Mrs Margaret Kendall has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

North Warwickshire Borough Council has been consulted as required by section 120(2) of the 1980 Act;

BY THIS ORDER:

1. The public right of way over the land situate at **Middleton** and shown by a bold continuous line on the plan numbered SC2023/T9 contained in this Order ('the Order Plan') and described in Part 1 of the Schedule to this Order shall be stopped up upon the issue by the authority of a written certificate to certify that the new route is fit for public use and works to implement the Order have been satisfactorily complied with.
2. There shall be at the end of 7 days from the date of confirmation a Public Footpath over the land situate at **Middleton** described in Part 2 of the Schedule and shown by a bold broken line on the Order Plan.
3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

SCHEDULE

PART 1 DESCRIPTION OF SITE OF EXISTING PATH OR WAY Between Points A – B on the Order Plan

That section of Public Footpath T9 from Point A (grid reference 417119 - 297000) to Point B (grid reference 417514 - 296931), a total distance of approximately 419 metres as shown on the Order Plan.

PART 2
DESCRIPTION OF SITE OF NEW PATH OR WAY
Between Points A – C - D on the Order Plan

From Point A (grid reference 417119 - 297000) running generally east to Point C (417402 - 296932) then running north to Point D (417453 – 297043) a total distance of approximately 412 metres as shown on the Order Plan.

The new route shall have an available width of 2 metres.

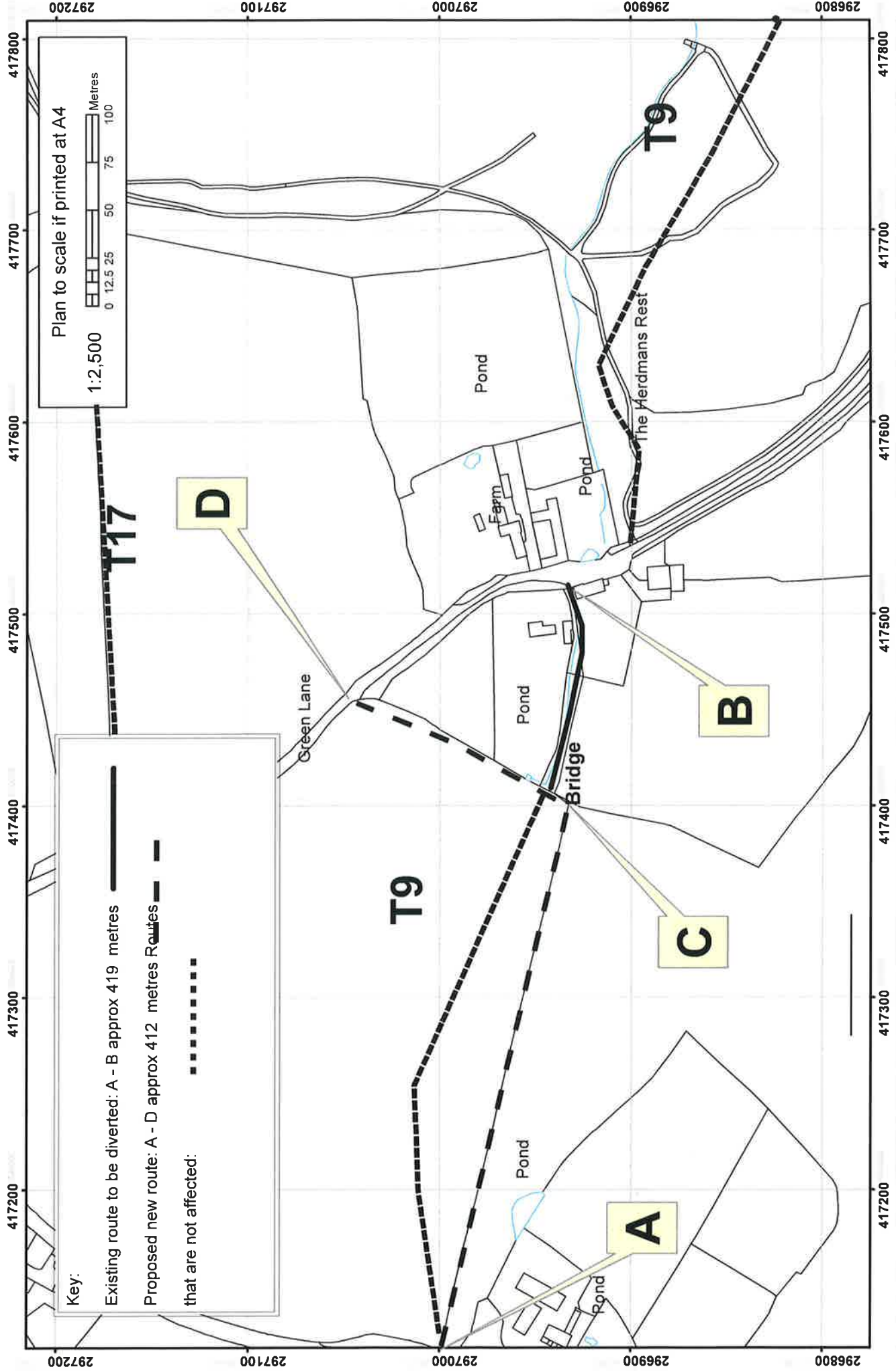
