that a highway shown in the map and statement as a highway of a particular description ought to be shown as a highway of a different description.

The authority have consulted with every local authority whose area includes the land to which the Order relates. The Warwickshire County Council hereby order that:


1. For the purposes of this Order the relevant date shall be **9 September 2025**

PART I**

MODIFICATION OF DEFINITIVE MAP SHEETS SP46NW and SP47SW

Description of path or way to be upgraded

A Public Bridleway in the Borough of Rugby and the Parish of Frankton, to be upgraded to Public Restricted Byway, shown as dotted green line on plan reference R209/DJL/Plan-1 (annexed hereto).

The route starts from its junction with A423 Oxford Road (grid reference SP 4049 6973). It generally runs North East for approximately **955** metres to its junction with E2251 The Dingles (grid reference 4131 7006) , shown on the attached plan reference R209/DJL/OrderPlan

The width of the route is 3 metres. Surface type part ash, padded track and grass. There are field gates at point A (grid reference SP 4050 6974), point B (grid reference 4079 6993) and point C (SP 4100 7004) .





