Introduction

The Autumn Audit, is a survey of Warwickshire childcare providers who provide 15 hours of government funded childcare places for 2 year olds who qualified for 2Help funding and all 3&4 year olds until they are of compulsory school age. The survey aims to establish the true supply of childcare places in the County and any issues settings have in being able to provide childcare places.

The 2013 Autumn Audit of childcare providers was distributed during the Autumn term to all childcare settings in Warwickshire that provide funded 2 year old places and/or NEF places. The survey sought to gain information on the providers ability to provide places for 2, 3 and 4 year olds, their ability to provide childcare for those children with a disability, the use of childcare vouchers or tax credits by parents and also to gain some insight into the qualifications of the Early Years workforce.

All 280 providers in receipt of 2 Help funding and/or Nursery Education Funding (NEF), of which 40 are child minders, are obliged to complete and return their Audit form. The data is analysed by Children Centre groupings and reach areas in order to correspond with the Childcare Sufficiency Assessment.

This year the survey was all completed online via Survey Monkey. A copy of the survey questions sent to the providers can be found in Appendix A.

All data has been reported as submitted by individual settings; it is, therefore, possible that errors were made by providers when completing the form. Due to changes in how provider registration details are now recorded by Ofsted, it is not now possible to find out the difference between the places for NEF and what the setting is registered for.

Funded 2 year old providers




Figure 1 - 2 Help providers by provider type

This is the first year that we have been able to survey the 2Help funded providers. We received replies from 197 providers who stated they provided 2 year old places. Figure 1 shows the providers by type.

Places and Vacancies

Providers were asked to provide details about the maximum number of full time (15 hour only) funded places that are practicable, reasonable and sustainable to offer at the setting. This question is designed to get a true figure of how many funded places that a provider can provide. The settings were also asked to provide the number of vacancies they had for full time funded 2 year old places. Figure 2 shows the maximum number of places a provider said it could provide and the number of vacancies by children centre grouping and area. The table also shows the number of eligible children per grouping according to figures from the Department for Education (DfE).

In all the areas, the maximum number of places that providers said they are able to provide is more than the number of eligible 2 year olds. However, from September 2014, the amount of eligible 2 year olds will double which may put pressure on places in some areas, especially where the number of vacancies is low but demand is likely to high, in Rugby or Bedworth, for example.

Factors limiting the number of 2Help places providers are able to offer

Providers were also asked to provide details of any factors which affect them being able to provide more 2Help places, figure 3 shows the results of this. The most common issue across most areas is that the space and layout of the setting restricts further places being made available.

Providers were asked to state if they could accept more 2 year old places. Overall, in the county, just over 18% (36) of providers stated that they were able to accept more places, however, figure 3 shows that this varies across the county.

The settings were also given the opportunity to provide comments if the reasons given did not reflect why they did not offer more 2Help places. A table of all the comments can be found in Appendix B – Data Tables. Broadly, the comments were concerned with wanting a balance between other age groups, not having enough available sessions to provide full time places and that the settings were currently expanding in order to provide some, or more, 2 year old funded places. A couple of comments stated that they felt the children eligible for the 2Help funding presented a higher workload due to their circumstances (e.g. CAF or learning difficulties).

3 & 4 year old NEF providers




Figure 4 - NEF providers by provider type

Replies were received from all 270 active NEF providers. Figure 4 shows the providers by type.

Places and Vacancies

Providers were asked to provide details about the maximum number of full time (15 hour only) funded places that are practicable, reasonable and sustainable to offer at the setting. This question is designed to get a true figure of how many funded places that a provider can offer. The settings were also asked to provide the number of vacancies they had for full time NEF places. Figure 5 shows the maximum number of places a provider said it could provide and the number of vacancies by children centre grouping and area.

The table also shows the population of 3&4 year olds and the number of that age group that attended maintained nursery provision. By showing the population and the number of children attending maintained nursery provision, it will give a better overview of how much provision could be needed in private, voluntary and independent (PVI) sector.

At first look, it seems that demand outstrips the supply of places for NEF eligible children, however the majority of the 4 year old population would have started school in September. The latest Warwickshire Childcare Sufficiency Assessment (2013-14) details the supply and demand of NEF places in Warwickshire in more details. Factors limiting the number of NEF places providers are able to offer

Providers were also asked to give details of any factors which affect them being able to provide more NEF places, figure 6 (page 8) shows the results of this. The most common issue across most areas is that the space and layout of the setting restricts further places being made available.

Providers were asked to state if they could accept more NEF places. Overall, in the county, almost 19% (52) of providers stated that they were able to accept more places, however, figure 6 shows that this varies across the county.

The settings were also given the opportunity to provide a comment if the reasons given did not reflect why they did not offer more NEF places. A table of all the comments can be found in Appendix B – Data Tables. Broadly, the comments were concerned with wanting a balance between other age groups, not having enough available sessions to provide full time places and that it depended on how many younger children they had. A couple of comments were that the hourly rate did not cover the true cost of providing the 15 hours of childcare.

Childcare for children with a disability




Figure 7 - Percentage of childcare providers that are able to offer different types of support to disabled children

Providers were asked to identify the areas where they felt able to support disabled children in their childcare setting. Figure 7 shows the results of this question.

Most providers feel able to support disabled children in terms of access to the setting and facilities, 73.6% (206), and also feel that they have the staff with relevant skills and experience, 83.6% (234), to be able to offer childcare to children with a disability. However, this fluctuates across the county, with all providers in Kenilworth feeling that their staff have the relevant skills in supporting disabled children but only 65% being able to offer support in terms of physical access.

Providers seem less confident in providing support to disabled children with specialist resources and in the level of staffing needed to offer appropriate childcare. The full results table by Children's centre can be found in Appendix B – data tables. Providers were able to leave comments on any difficulties they had encountered in trying to offer childcare to disabled children. Most comments highlighted that providing one to one care and support is difficult and that funding to improve facilities, get specialist resources and to train staff is not easily available. Full list of comments can be found in Appendix B – Data Tables.

Childcare vouchers

Providers were asked to give information on the promotion and use of childcare vouchers in their setting. Figure 8 shows the results to this question.

Overall, the promotion of childcare vouchers across the county is good, with at least three quarters of providers in all areas promoting the use of childcare vouchers to their parents. Take up of the childcare voucher scheme seems to vary across the county. In Bedworth, only 97 parents make use of childcare vouchers, which is low considering the number of families in the area. The reason for this may be that local employers do not offer a childcare voucher scheme, or that parents are not aware of the benefits of using the vouchers. One other possible reason is as the vouchers are based on tax credits, it may work out that the families would be worse of using childcare vouchers rather than tax credits.

Changes in how childcare vouchers are distributed will change from autumn 2015. Parents will be able to buy vouchers online to pay for childcare with every 80p they spend, the government will add 20p. The scheme is available for up to £10,000 of Ofsted registered childcare costs per child each. (Guardian, 2014).

Early year's workforce - GCSE Maths and English

Providers were asked to give information on whether their staff that work directly with children have GCSE (or equivalent) Maths and English grade C or above. Figure 9 shows the results to this question.

Figure 9 shows that EY workers are more likely to have GCSE (or equivalent) Grade C or above in English rather than Maths. In both Nuneaton and Kenilworth, under 75% of the workforce have GCSE (or equivalent) grade C or above in either Maths or English. When comparing results at a Children Centre reach level (Appendix B – Data Tables) there are some areas where less than 50% of the workforce have GCSE (or equivalent) grade C or above in either Maths and/or English. These areas of concern are Mancetter, Abbey, St Nicholas and Newbold Riverside.

Conclusions and Recommendations

2Help Providers

197 responses were received from providers who stated that they provided 2 year old funded places. Overall, the maximum number of full time places that are practicable, reasonable and sustainable to offer at the settings was 1857 and the providers also stated that they had 713 full time vacancies for 2 year old funded children.

In September 2014, there is a requirement that Local Authorities ensure there is sufficient childcare for the 40% most deprived 2 year old children to take 15 hours of funding, double the current amount. In some areas like in Bedworth, Nuneaton and Rugby, there is likely to be quite a high demand for funded 2 year old places, however, using information from providers about vacancies, there may not be enough supply of places.

When asked about any factors that affect the provision of more funded 2 year old places the most common issue across most areas is that the space and layout of the setting restricts expansion. Other issues highlighted by providers were that they wanted to get the right balance of age groups and that the funded 2 year olds may present extra workload for staff.

NEF Providers

270 responses were received from providers who stated that they provided NEF places. Overall, the maximum number of full time places that are practicable, reasonable and sustainable to offer at the settings was 6318 and the providers also stated that they had 1661 full time vacancies for NEF eligible children.

As with the two year old settings, providers stated that the most common reason for not being able to offer more places is because of the space and layout of the building. Other issues highlighted by providers were that they wanted to get the right balance of age groups and the funding does not reflect the true cost of offering a childcare place.

Childcare for children with a disability

Most providers feel able to support disabled children in terms of access to the setting and facilities, 73.6% (206) across the county, and also feel that they have the staff with relevant skills and experience, 83.6% (234) across the county, to be able to offer childcare to children with a disability.

Providers were able to leave comments on any difficulties they had encountered in trying to offer childcare to disabled children. Most comments highlighted that providing one to one care and support is difficult and also that funding to improve facilities, get specialist resources and to train staff is not easily available.

Childcare vouchers

Overall, the promotion of childcare vouchers across the county is good, with at least three quarters of providers in all areas promoting the use of childcare vouchers to their parents.

Take up of the childcare voucher scheme seems to vary across the county. In Bedworth, only 97 parents make use of childcare vouchers, which is low considering the number of families in the area.

Early year's workforce - GCSE Maths and English

EY workers are more likely to have GCSE (or equivalent) Grade C or above in English rather than Maths. In both Nuneaton and Kenilworth, under 75% of the workforce have GCSE (or equivalent) grade C or above in either Maths or English. When comparing results at a Children Centre reach level (Appendix B – Data Tables) there are some areas where less than 50% of the workforce have GCSE (or equivalent) grade C or above in either Maths and/or English. These areas of concern are Mancetter, Abbey, St Nicholas and Newbold Riverside.

Recommendations

- In order to ascertain the real needs of disabled children in childcare and the difficulties childcare settings have in being able to meet the needs of disabled children, further work should be done in conjunction with the Integrated Disability Service.
- It would be beneficial for some more work to be done in Bedworth to ensure that parents are aware of childcare vouchers and how to use them. It would also be useful to promote this to local employers
- It would be beneficial to work with providers in areas where GCSE attainment is lower than 50% to establish if there is a need to improve the GCSE figures and work with Adult Community Learning to identify any support that could be given.

Comments

Our setting is not age specific - places are on a first come first serve basis

We don't have enough vacant places to offer the full 15 hours to any new 2 year olds. We could only offer 2 sessions 9.15-1 this academic year but could offer more from next September.

Currently increasing our places from 4 to 8. due to high level of demand.

Outdoor area needs improvement, a grant has been applied for to replace grassed area with a soft surface as some areas are affected by tree and hedge roots resulting in bare patches.

MORE TOILET AND WASHBASIN FACILITIES

2 year old room is at capacity

We could if we had places but we have a long waiting list.

It depends which day of the week and if we have spaces now and in January as we are planning sessions for then.

Answers to questions above on 2 years olds - would not let me put answer "variable" which is correct answer...it depends!

Also limited to space as share room with before/afterschool club

We would accept as many 2 year places as we had spaces but maximum numbers are 24 children per session due to space

We are happy to recruit/extend hours of current staff as demand for 2 year old places occurs as we don't currently have any full time spaces, only some 3 hour sessions available on certain days.

Our occupancy levels are currently high so we just do not have the availability

We take a maximum of 18 children per day - regardless of age/funded/non funded

We are discussing with Diana Spragg whether we would be able to offer temporary accommodation for children who have been told a PreSchool is closing in Rugby.

very busy this academic year- no vacancies for the full 15 hours

Room only available 3 mornings (9 hours)

We are at capacity on certain sessions which restricts us to use the other sessions

It all depends on the level of disability/special needs and the care required

We are based in a portacabin with steps up to enter

No disabled toliet but we do have ramps and easy access to the garden

We don't have sufficient funds at present to employ one to one helpers for children with such needs.

There isn't usually any extra funding available for one to one care so we need to assess on an individual basis to ensure we do the best for each child in our care
