It is an offence to kill, injure, disturb or destroy European Protected Species and National Protected Species and their places of shelter or protection - whether or not planning permission is granted. This includes bats, birds nests or sightings of species such as bats, badgers, dormice, otters, slow worms, adders, grass snakes, common lizards, southern damselflies, great crested newts, water voles and nesting birds, great crested newts, otters and dormice. If Protected Species are found during the course of any works you must stop work immediately and contact Natural England because Protected Species legislation still applies.
