(FOOTPATH M449 OVER WHITACRE) PUBLIC PATH EXTINGUISHMENT ORDER 2013

The above Order, made on 23 April 2014, under section 118 of the Highways Act 1980, will **EXTINGUISH** the full length of public footpath M449 from Point A on the B4114 Coleshill Road (grid reference 42487 29128) running generally east for approximately 140 metres to Point B on the B4114 Nuneaton Road (grid reference 42501 291129) as shown on the Order Plan.

A copy of the Order and the Order Plan have been placed and may be seen free of charge at the offices of Warwickshire County Council, Shire Hall, Market Square, Warwick CV34 4SA from 8am - 5.30pm on weekdays, (5pm Fridays) and 9am - 4pm Saturdays. Any representations about or objections to the Order may be sent in writing to the Strategic Director of Environment & Economy, Barrack Street, Warwick CV34 4SX, not later than 23 April 2014. Please state the grounds on which they are made. Representations or objections may become publicly available and therefore the names and addresses of those persons making representations or objections would also be made publicly available.

If no such representations or objections are duly made, or if any so made are withdrawn, Warwickshire County Council may confirm the Order as an unopposed Order. If the Order is sent to the Secretary of State for the Environment, Food and Rural Affairs for confirmation any representations and objections which have not been withdrawn will be sent with the Order.
