SD92 on SP35SW starts of from the county road D6364 Church Hill at Combbrook by the red house at grid ref 3165 5190 to the junction with SD91 and the county road D6437 at Brookhampton at grid ref 3195 5067 It is some 1.2 Kilometres long and some 3 metres wide for 50 metres near the start then 5 metres wide for the remainder of the route .It follows a hedge on one side for most of the way and there are five gates along its length .The surface is of padded grass with open country to one side .The route is well defined on the ground.

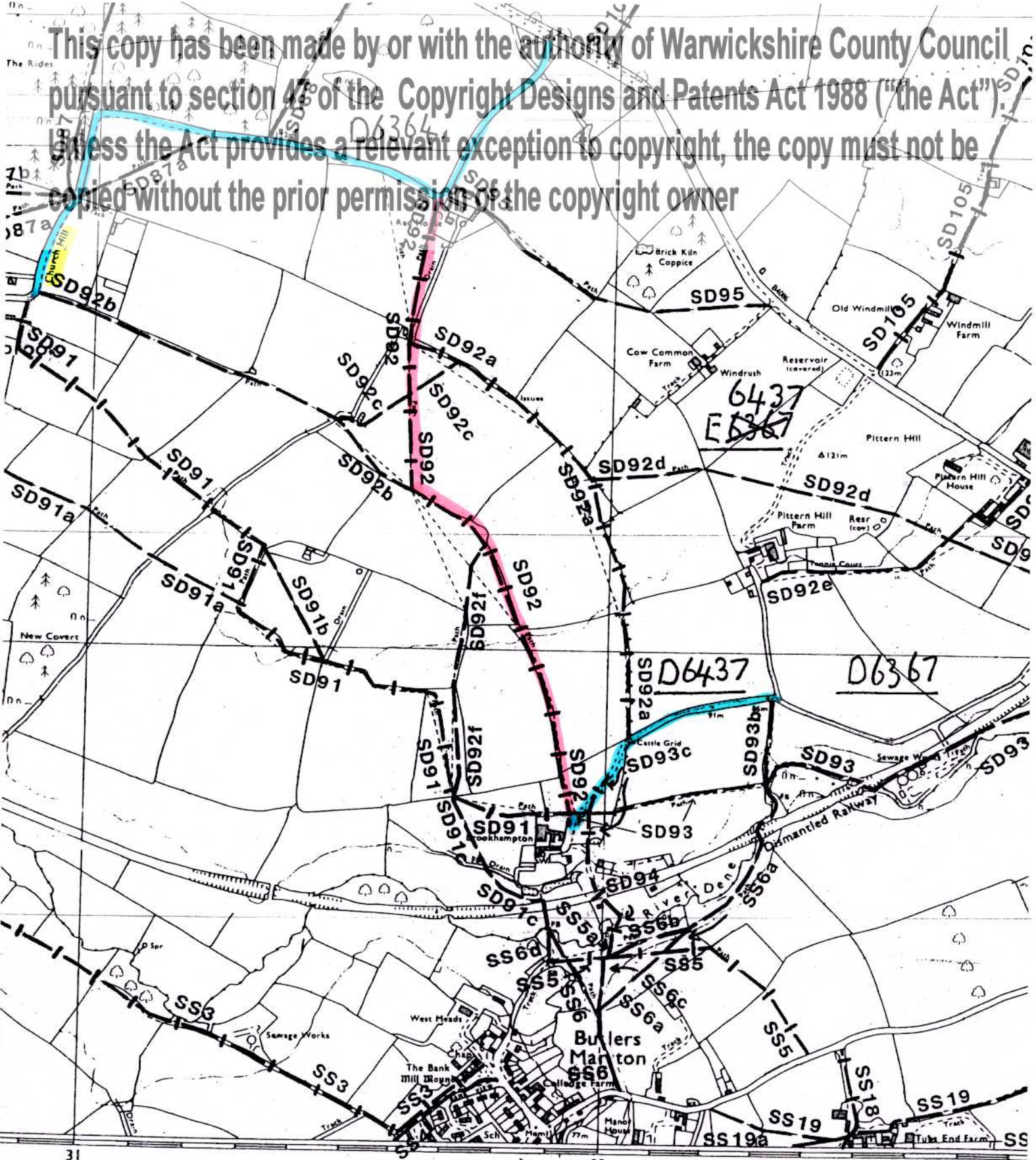
