## Statement of Evidence for RA ref. SD Claim 116 (Wellesbourne)

- 1) The claimed route was set out in the Wellesbourne Hastings Inclosure Award 1733 (County Record Office QS9/11m.17-19). This described it as the road "from Wellesboune to Moreton and specified it as being 40 feet wide.
- The Award does not include a plan, but there is an estate map of the same date (CRO CR750/2) which is described as being "taken upon the Inclosure". This shows, and labels, the route as a road called "Moreton Road", and includes that part of SD311 which lies within the parish.
- 3) The route is also shown on an estate map of 1841 (CR2269).
- The status, and route, of the claim is confirmed by the deposited plans for the proposed Midland and Eastern Counties Railway 1845 (QS111/184). This shows the route and lists it as parcel number 25a in Wellesbourne Hastings parish. The Book of Reference describes it as a "Public Road" with the owner being given as the "Surveyor of Highways".
- 5) The route is shown on subsequent, large scale, Ordnance Survey maps with the continuation of the route being recorded on the Definitive Map as a bridleway, numbered SD311.
- 6) There are no records of the route either being closed or diverted, either at Quarter Sessions or subsequently.
