SD309 starts off the county road C141 via double gates onto a 18 foot wide stony track up a gentle slope with a hedge on one side up to a farm building, where there is a further gate. It then becomes a 18 foot wide padded grass track with open fields on each side to the point where it joins the county road E6537 and again becomes a stony wide track, then onto tarmac at D6537. Total length 750 metres.

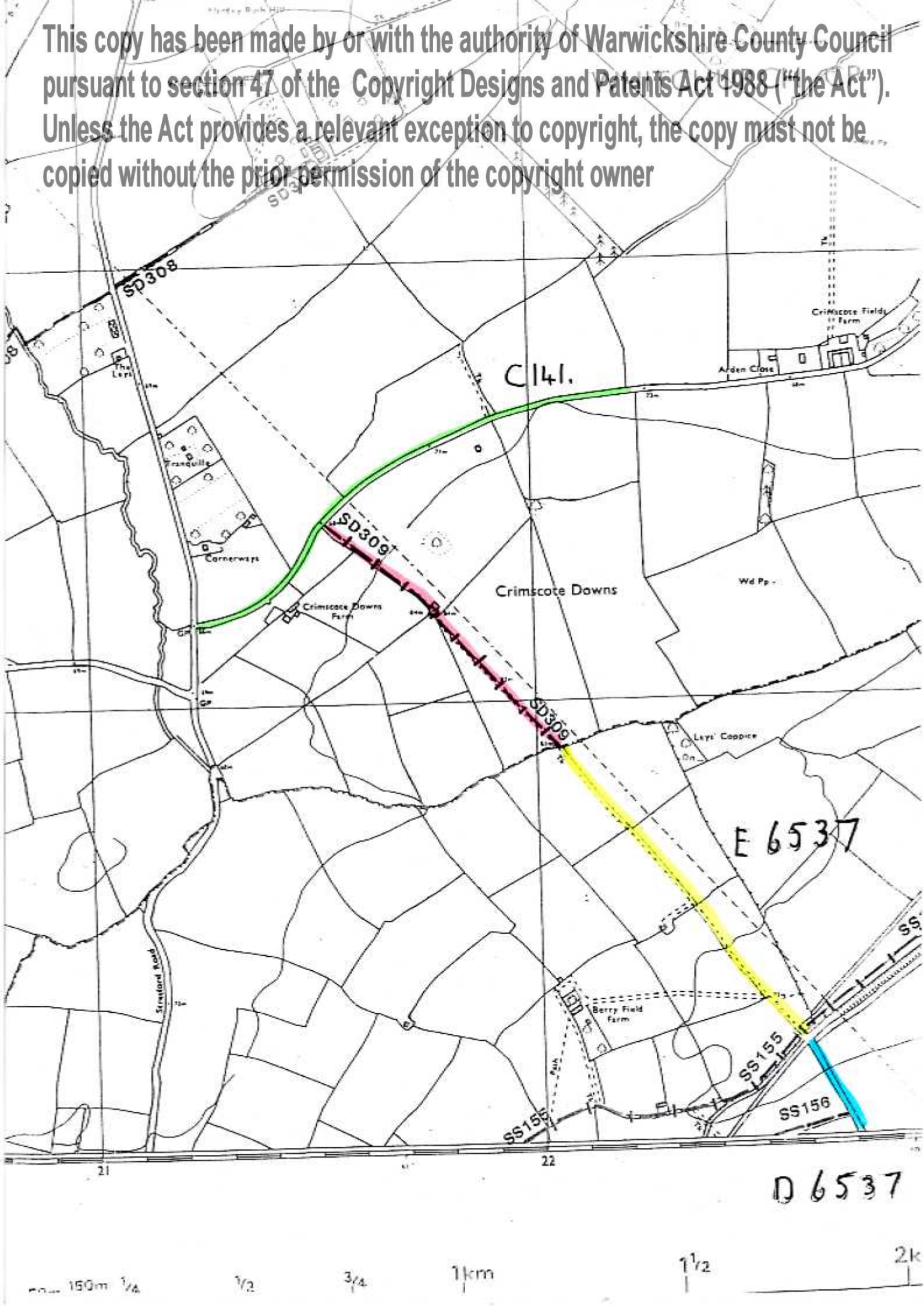
