THERE IT BECOMES THE E6993 FOR A FURTHER 360 METRES TO THE JUNCTION WITH THE SD52. AT GRID REF: 1926-5064 THEN FOR A FURTHER 250 METRES TO THE D6511 AT GRID REF: 1950-5052.

THE SURFACE IS PART STONE PART COMPACTED EARTH. WET IN PLACES. IT IS ALSO HEDGED IN PLACES. IT IS NOT LESS THAN 30 FEET WIDE THROUGHOUT.

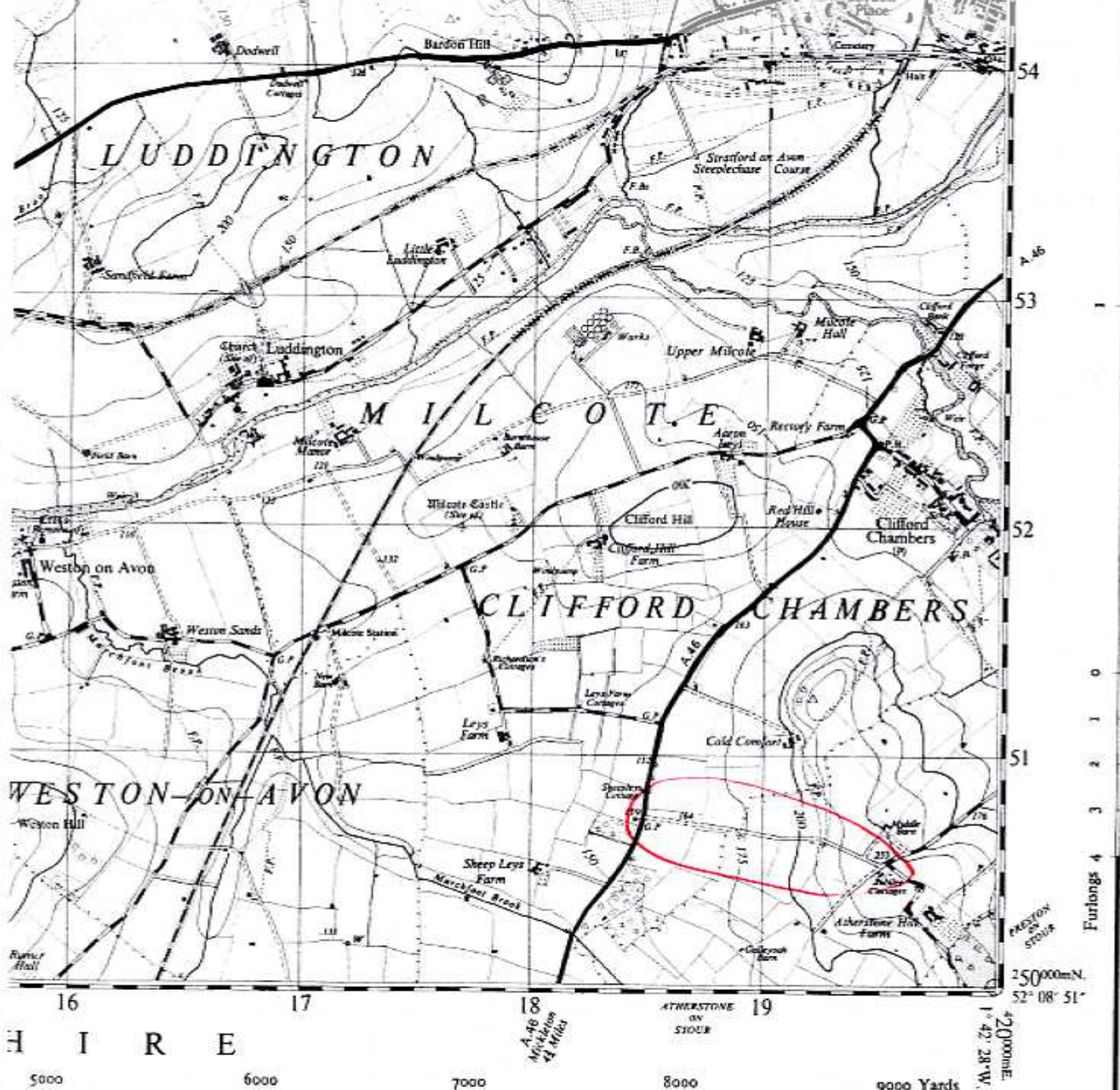
