Description :

SD340 on definitive maps SP16SE and SP16NE starts at the southern end of Breach Lane the county road D5256 at Grid Ref. 1942 - 6465 and runs for 900 metres in a north westerly direction to join the Henley Road the A4189 and Kington Lane the D5257 at Grid Ref. 1862-6510. The lane is well defined some 5 metres wide with encroaching trees and hedges. N.B. This part of SD340 was known as Coulters Lane in the 1920's.

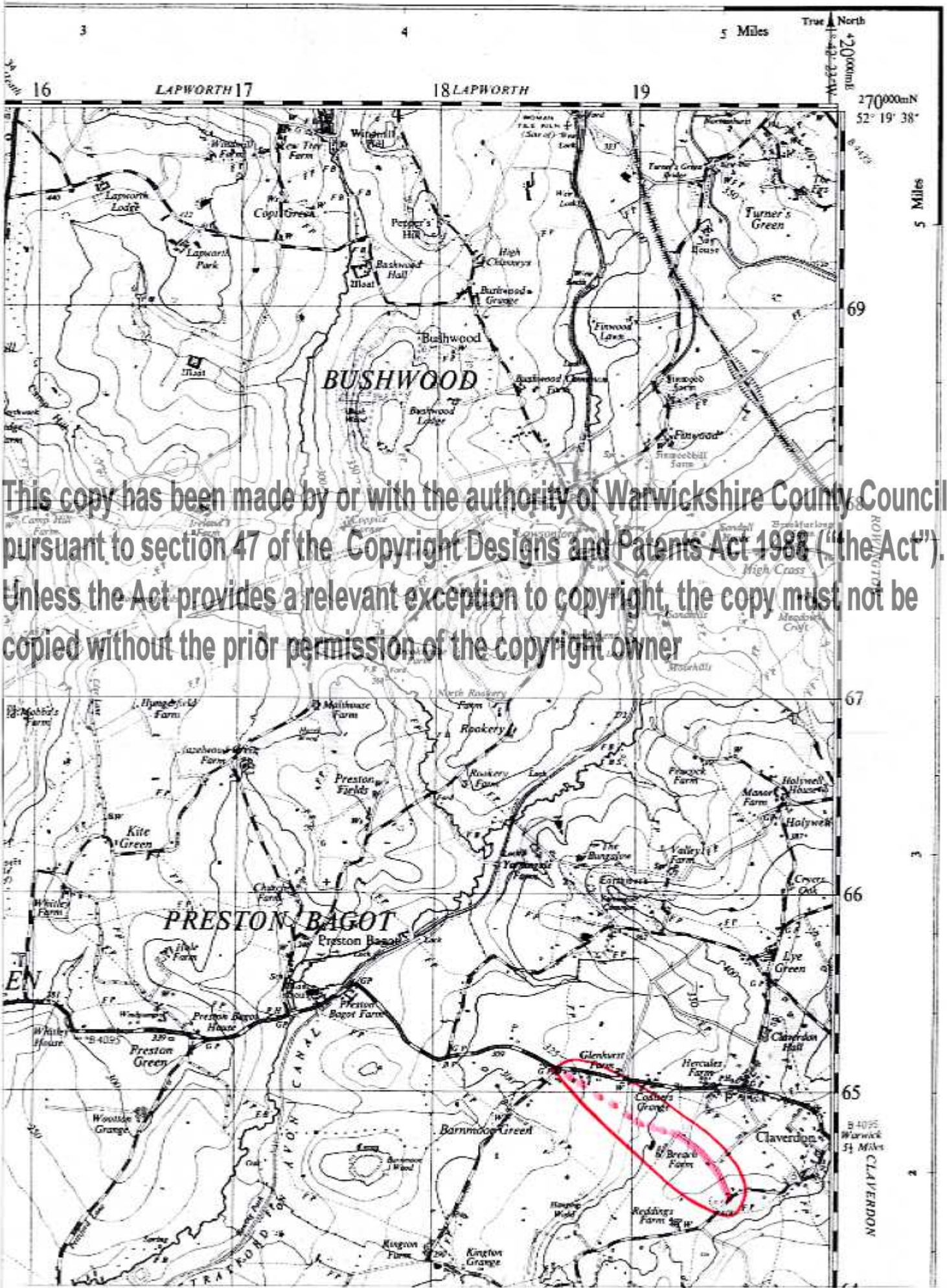
