SS3e is a branch off SS3 starting at Grid Ref: 3036-5034 on SP35SW, it runs in a south easterly direction for approximately 1 kilometre to the county road B4451 at Grid Ref: 3112-4961 on SP34NW. From its junction with SS3 it is some 4-5 metres wide throughout between hedges with a padded grass surface. It continues as such with a hedge on the east side up to Lobbington Farm, thereafter it continues with a hard packed surface fenced and hedged on the east side up to the B4451, there are some 4 gates along its length.

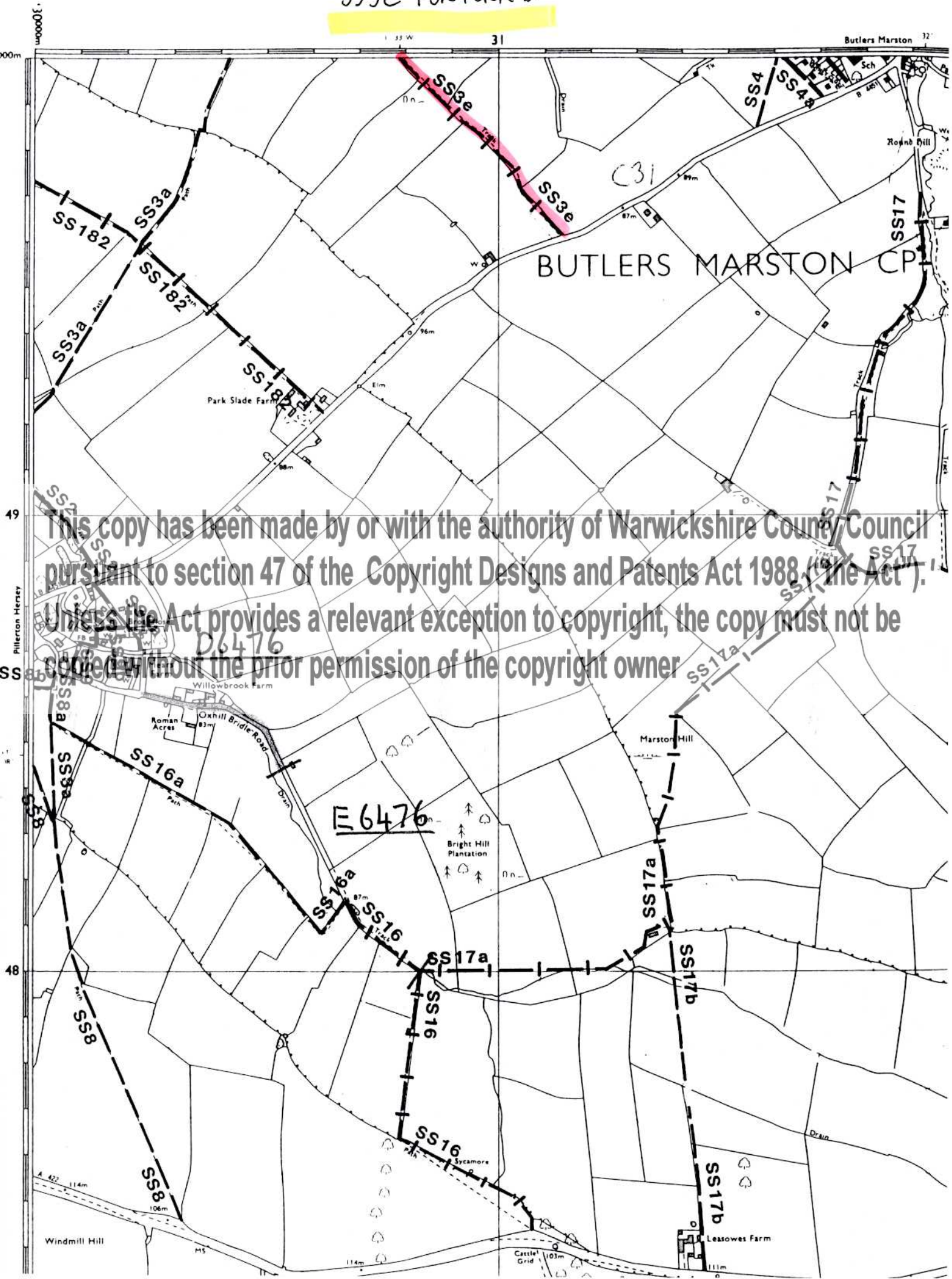
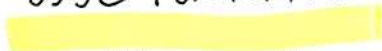
