Statement of Evidence for RA Claim SD15

- 1) Edge Lane generally follows the parish boundarey between Preston Bagot, Beaudesert and Wootton Wawen and is shown on the relevant estate maps. The first of these is of the Lord Leigh Estate in 1767 (County Record Office Z149(Lsep)). Map 12: Preston Bagot shows the section north from Kites Green on the boundary of the estate, with a path leaving it to cross two fields to the south of Hungerfield Farm This path now forms part of the Heart of England Way.
- 2) There are two maps of the property of Kings College, Cambridge, to the west of Kyte Green. The earliest (c. 1776) does not show Edge Lane (Z190/4(u)), although it is the boundary of the holding. The second map is dated 1800 and the inset for Whitley Farm (Z190/5(u)) shows the lane and labels it as "to Leveredge Hill" on the north and "from Preston Green" to the south of Kyte Green. The path now forming part of the Heart of England Way is shown as crossing the estate "From Henley" upto Edge Lane and then continuing (slightly to the north) from the lane "To Bushwood Common". The fact that the path stops and starts at the lane supports the implied public nature of the lane (created by its "to" and "from" descriptions) and this is strengthened by the fact that the path is not a direct crossover.
- 3) The Tithe Apportionments of these three parishes all show Edge Lane. The earliest is that for Preston Bagot, 1839 (CR569/192). This shows even the parts in Beaudesert and Wootton Wawen where they form the boundary, the part in Preston being coloured in the same way as all the other roads in the parish. Edge Lane, and its continuation to the south (Kite Green) and beyond, and then west towards Whitley Farm, is numbered 22 on the map. The Book of Reference simply describes this (and the others) as "Road", with no tithe payable.
- 4) The Tithe Map for Beaudesert (1841) (CR569/23) again shows Edge Lane coloured, as all other roads in the parish. Neither this lane, or any of the other roads, are numbered and none are mentioned in the Apportionment itself. They could not, therefore, have been liable for tithes which suggests they were all public highways.
- 5) The Tithe Map for Wootton Wawen, c.1843 (CR569/278 pt. 4) also has all the roads, including Edge Lane, coloured and not numbered (except for a few, short, ends of culs-de-sac). This again suggests that they were public, including Edge Lane.
- 6) In 1859 the first of a series of proposals for a Henley in Arden railway were deposited at Quarter Sessions (QS111/234). This shows the parish boundary between Preston Bagot and Beaudesert as going down the middle of Edge Lane, with both sides being described as "road" in the Book of Reference, with the owner as including the Surveyor of Highways. The drawn section shows and labels it as "Road level unaltered" 59 feet above the proposed railway, clearly indicating that the road was not to be closed. A similar proposal in 1860

- (QS111/240) used the same route and numbering as in the above proposal, and gives the sole owner as the Surveyor of Highways, with no occupier.
- 7) A variation to the proposed railway, in 1872 (QS111/329), describes the line of Edge Lane as "Part of site of a road dissected by uncompleted railway cutting", with the owner as still including the Surveyor of Highways. This is repeated in the proposals for the Henley in Arden and Gt Western Junction Railway 1883 (QS111/404). These clearly show that the road has not been closed since, otherwise, the Surveyor of Highways would not be listed as an owner.
- 8) This is further supported by the fact that the land registry shows a break in the field ownership for the line of Edge Lane.
