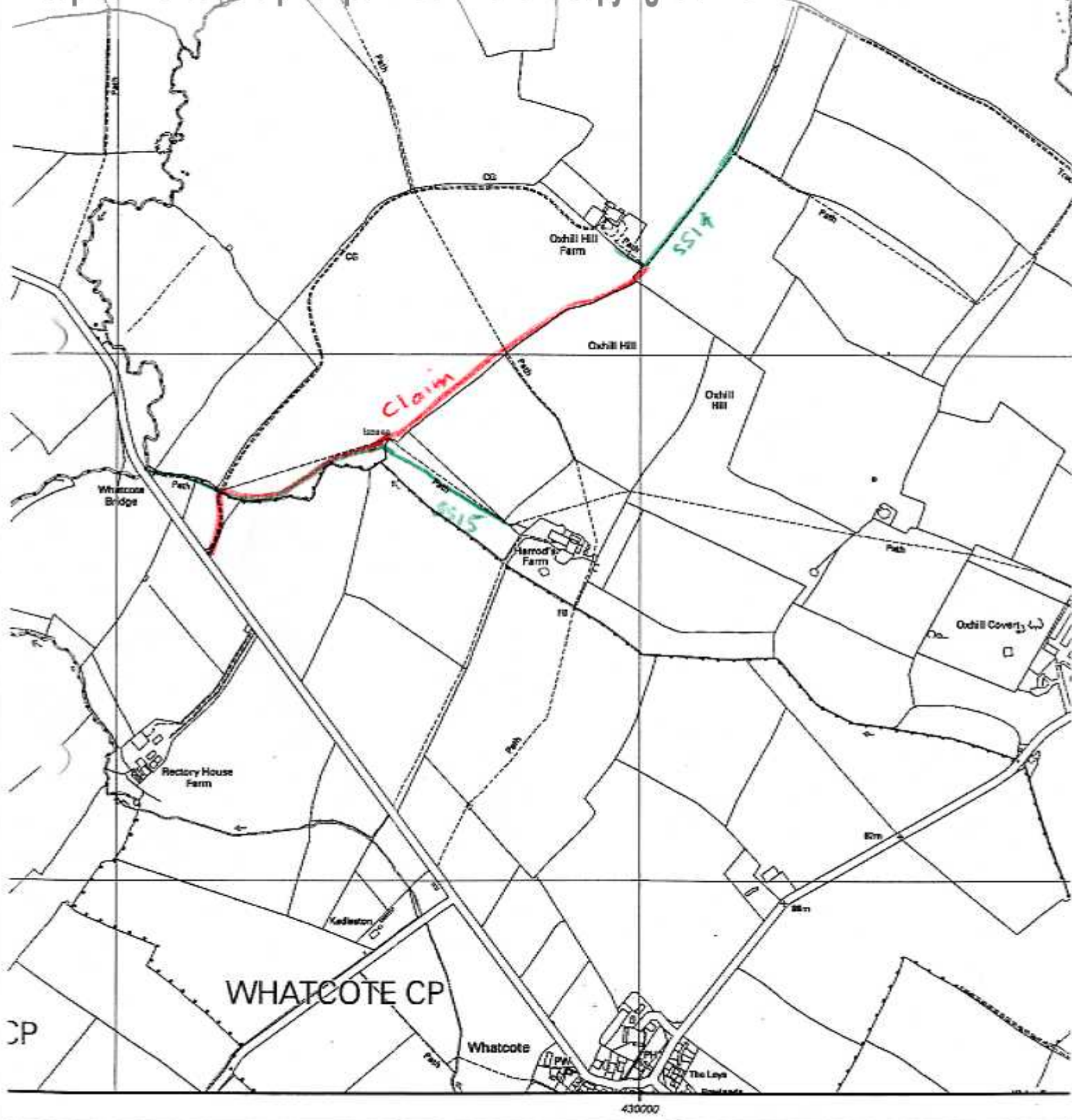

Statement of Evidence for Shipston Claim No.11

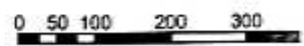
- 1) The main part of this claim was created by the Oxhill Inclosure Award 1798 (County Record Office QS75/84 and CR1134/1). The second reference includes a plan which labells Lower Field Road (= part of path SS14a) and Stone Pit Road (= part of path SS14a, the present claim, and part of path SS15). The bridleway was to be 20 feet wide.
- 2) The Whatcote Inclosure Award 1803 (QS75/125) has its map at refence 'P20' and includes a public bridleway 30 feet wide "leading out of the Stratford Road in Oxhill Brook Furlong and extending in a northward direction over the third allotment ...". 'P20' actually comprises 4 documents, including the 1803 plan, which shows and labells the paths.
- 3) The Oxhill Vestry Minutes (DR277/4: 1865-1883) record, at 5<sup>th</sup> October 1868, an indictment for repair of 'certain roads' and a proposed application to stop up Stone Pit Road. It also records, at 30<sup>th</sup> September 1879, a discussion about the maintenance of this same bridle road "to the Whatcote and Fulready Road" (= bridle road to Halford Bridge). This establishes that the route did continue beyond the part shown on the Definitive Map.
