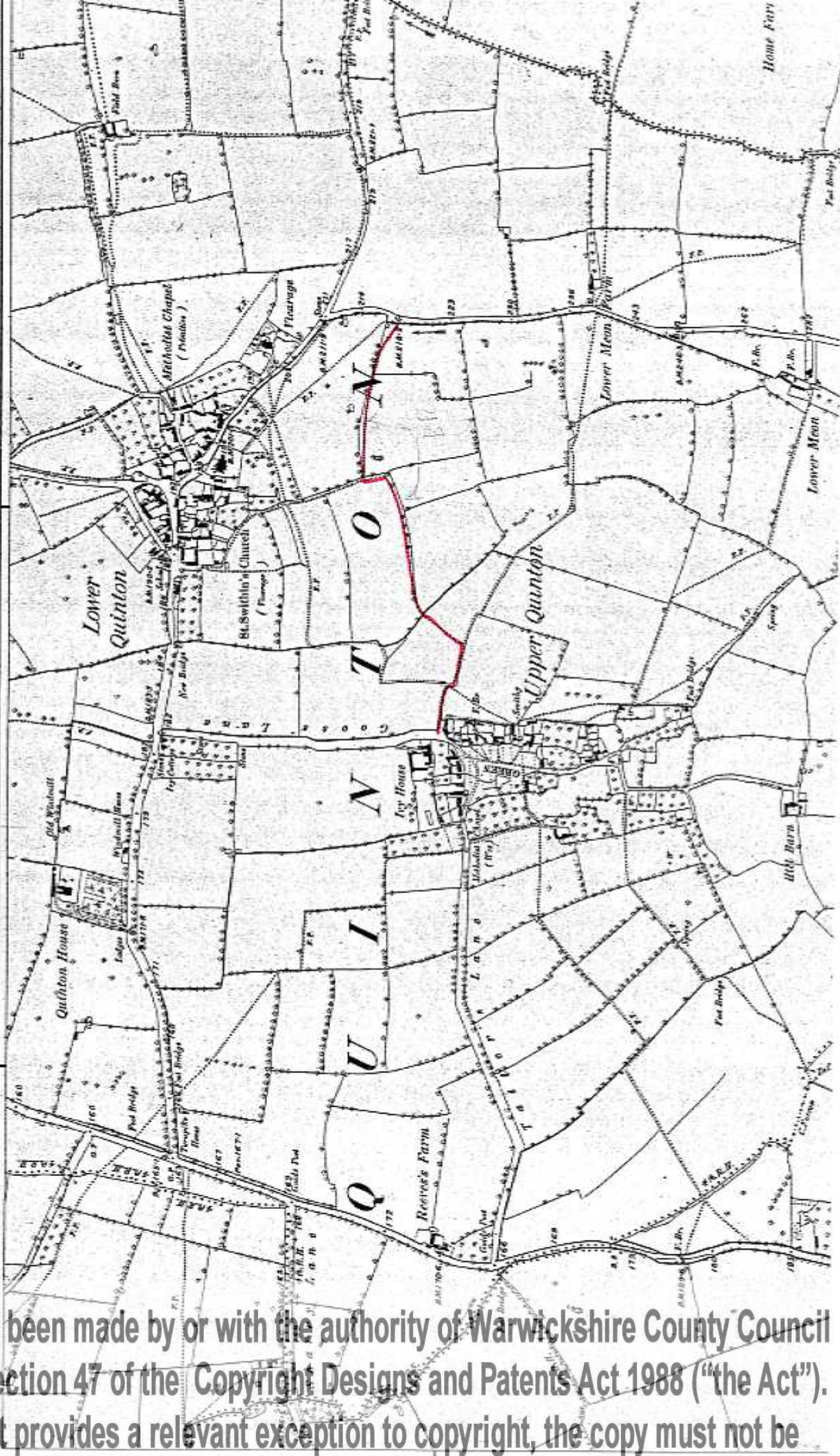
Statement of Evidence for RA Ref. SD Claim 91 (Quinton)

- 1) This bridleway is first mentioned in the Quinton Inclosure Award 1773 (County Record Office ref. QS75/89). The Award, however, is not accompanied by a map but a reconstruction enables the route of the awarded bridleway to be determined. (A copy of this reconstruction has been deposited at the County Record Office.)
- 2) This bridleway (the only one awarded) is prescribed as being being 15 feet wide. Its route is described, in detail, as beginning at the north end of John Edwards homestead, which can be located at the north end of Upper Quinton due to the description of the first awarded public footpath. It then went east over a small part of the first allotment to John Edwards "at the north end thereof" and then on the south side of the first allotment to Thomas Edwards Freeman to the east end of Lower Chicken Furlong where it turned north and entered the allotment to the President and Scholars of Magdalen College, Oxford (in tenure of Edward Walford) at the west end of Kecks Leys Furlong. It then passed through this allotment to a gate in the fence of the ancient inclosure of Thomas Corbet Southam (part of the estate of the same college) called the New Ground.
- 3) An estate map of 1808, showing the old inclosures of Magdalen College, Oxford (CRO DR328/26) identifies "New Ground" and marks the various footpaths as well as the Bridle Road, which is labelled as being 15 feet wide. This confirms the existence of the bridleway and establishes the precise position of the gate mentioned in the Inclosure Award.
- 4) The area called "New Ground" is also identified on a later estate map, namely that of 1868 (CRO Z128/2(u)), although no paths are shown. This estate map shows the whole of the landownership of the President and Scholars of Magdalen College, Oxford, including the land awarded in the Inclosure Award.
- 5) The first and second editions of the Ordnance Survey large scale maps show, and label, the claimed route as "BR" (i.e. bridle way).
- 6) The line of the claimed bridleway crosses two hereditaments on the maps prepared under the 1910 Finance Act, namely numbers 45 and 58. The first of these hereditaments claimed two footpaths and a £30 deduction under the heading 'public rights of way or user', while the other claimed £100 deduction under the same heading. The owner of this second hereditament was given as the Bursar of Magdalen College, Oxford.
