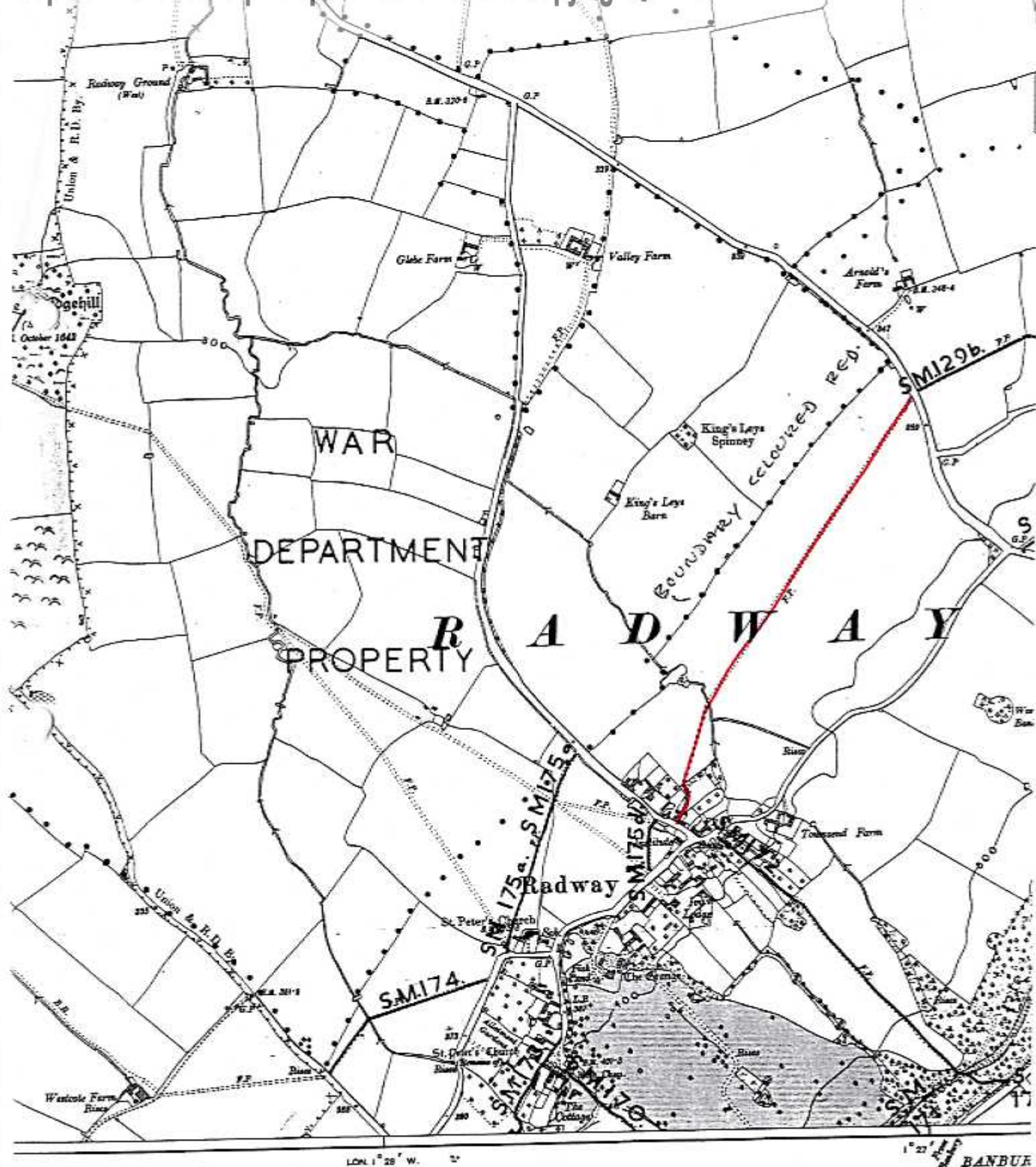

Statement of Evidence for Southam Claim No.8

- 1) This path was created by the Radway Inclosure Award of 1757 (County Record Office ref. QS75/90). It was part of the 5th awarded footpath the whole pf which is described as the "New Path to be made from Ennocks Corner at the North end of Radway Town over Hemp Close through the allotment to Sanderson Miller in Townsend Quarter, over the east end of the allotment to Sanderson Miller, and through the allotment to him in lieu of, and the East end of the allotment to John Daniel to the North end of the last allotment then to Cosford Gate. 4 feet broad. To be continued and used as a private Path or Footway". (N.B. this reference to 'private path' should be interpreted as meaning for the use of the parish, not the present day meaning.)
- 2) These allotments can be identified by reconstructing the map of the Inclosures and shows that the first mentioned allotment is the 2nd to Sanderson Miller, the next one was in lieu of lands purchased from William Barrett, the third was in lieu of lands purchased from Hayes and Pettit, and the allotment to John Daniel was in the north-west corner of the parish. A copy of this reconstructed map has been deposited at the County Record Office.
- 3) A map of 1756 (CR1596/197) shows the pre-enclosure arrangements of fields, and an earlier arrangement of the proposed allotments. It does not show any paths, but does name Hemp Close so that the start of the path can be identified. The present day Hemp Cottage immediately adjoins the access to the then Hemp Close.
- 4) The claimed route is shown, and labelled, on all the large scale Ordnance Survey maps, including the first edition of the 6 inch to a mile map of 1886, and the base map used for the 1964 Order (see below).
- 5) The claimed route was shown on the original Draft Definitive Map as a public path. The then landowner objected to its inclusion (with others) and a counter objection was lodged by the Ramblers Association on 29 September 1958. Following receipt of information about previous (temporary) closures of the part of paths on land held by the Ministry of Defence, that part of our objection was withdrawn on 28 December 1958, but with the proviso that they would need to be claimed if the site was de-requisitioned. All of this establishes that the paths, including the present claim, were generally accepted as being public rights of way.
- 6) When the Modified Map was published, the claimed route was omitted, despite the Ramblers Associations outstanding objection to the deletion.
- 7) In 1964 the public paths across the Ministry of Defence land were permanently stopped up, by Order. This left a short cul-de-sac linking one of those paths (listed as No. 8) to the claimed route, and the claimed route itself, as unredorded public paths.
- 8) It is contended, therefore, that an error was made at the time of the preparation of the original Definitive Map and that the claimed route should be shown as a public path.
