Evidence

All references, unless otherwise stated, are to documents held by the County Record Office.

- 1) 1482 Survey of the Manor of Warwick (Z102)L). 1st entry in Hoggisford: the property described has, on its south side, the "way from Waldyche to Lethenhull" [Waldyche = Market Street, Lethenhull = Theatre Street, at this time.]
- 2) Deed of 1647, in Hoggesford (Birmingham Reference Library DV43/183811) is for a property which has, on its north side, the "Kings Highway from Corn Markett". [Corn Markett is part of the Market Place, at the top of the Holloway.]
- 3) All the town maps, published by the Record Office as the Town Maps of Warwick, show the route namely 1610, 1711, 1788, and 1806.
- 4) the route is shown on a plan of the layout of Warwick, by Henry Couchman, surveyor, and dated 4 February 1790 (QS24/578/15). Although no width is given (as it is for all the roads), there are three pairs of dots, one at each end, and one in the middle.
- 5) Board of Health Map 1851 (CR1618/W6/55) shows all roads and paths in detail and labels this as "Jetty", with paving the same as the footways in Market Street, and no barriers.
- 6) The route is clearly shown on all Ordnance Survey map, e.g. 1887, 1925, and more modern until the area was redeveloped and the path changed.
- 7) Borough of Warwick (Market Square) Footpath Diversion Order No.1, 1965: diverted the path from the Gospel Hall to Theatre Street. [The Gospel Hall was by the Market Place.] The new route was needed due to the comprehensive redevelopment of the Market Street area.
- 8) The route is heavily used by the public as a major pedestrian route in to the town centre and is surfaced with special paving slabs due to part of it being a ramp, and part steps. An ornamental arch has recently been erected to emphasise it as an entrance to the town centre.
