Evidence

All the references are to documents held by the County Record Office.

1) This path was specifically created by the former Warwick Borough Council, for which land was purchased at the top of Humphris Street.

2) Building Byelaw Plan for 45-75 Beauchamp Road and 2-8 All Saints Road (CR2487 Boxes 58-67 Plan No.536), deposited 1927 by Warwick Town Council, shows a rear access path from All Saints Road to bottom of garden of 73 Beauchamp Road.

3) Minutes of Highways and Water Cttee 17 July 1939 and General Purposes Cttees of 19 September 1939 and 17 October 1939 (CR1618/W22/32) report progress on acquisition of necessary land from the Warwick Castle Estate, and the intention to start work on the footpath.

4) Correspondence 1939-1943, and conveyance 10 June 1940, of the necessary piece of land at the top of Humphris Street (beside Oberon House, 78 Humphris Street) includes a plan of the 83 square yards of land and the path (CR1886/Box745/8).

5) The whole path is shown as adopted/maintainable on the Highway Authority plan kept by the District Council as agents.

6) The path is surfaced with standard, Highway Authority, paving slabs.

7) The path is used by local residents as a short cut to the shops and buses in Emscote Road.
