Evidence

All documentary references are to documents held by the County Record Office.

- 1) The path, now called Lock Lane, is the southwards continuation of path WB3 on the Definitive Map, to Millers Road at a point which was originally the end of Millers Lane.
- 2) WB3, and the present claim, have an origin earlier than the canal, which forms the boundary of the former excluded area. This is demonstrated clearly by the route being shown on the estate maps of the area as a separate, hedged, route from Cape Road along Millers Lane (a later name) and then diagonally across the 'grain' of the field pattern. (See 1711 map of the Priory Estate (CR26/2/2 + CR217), the 1788 map of the whole of Warwick (Z122(u)), and the 1806 map of Warwick (Z276/2(i)(u))
- 3) The route continued in use, after the construction of the canal, and is shown as a path on estate maps (e.g. 1803 (CR26/2/3), the Tithe Apportionment Map 1848 (CR569/75), and all large scale Ordnance Survey maps up to the time when Lock Lane was laid out in the 1930's (e.g. 1887 and 1925 editions of 1/2500 scale maps).
- 4) The route has also been acknowledged as being public for very many years, being shown on the Deposited Railway Plan 1845 (QS111/187) where it is described as a "Public Footpath" in the ownership of the Surveyor of Highways, and being shown and labelled on a development/sale plan of 1933 (CR1618/W6/8), prepared by the former Borough Council, as "Public Footpath".
- 5) The site of Lock Lane formed part of the "Packmores Estate" purchased by the former Warwick Borough Council in the late 1920's (CR1618/W22/22 p.128, Minute 21) and shown on a plan dated June 1928 prepared by the Council (CR1618/W6/9).
- 6) The route is surfaced with tarmac and has standard, Highway Authority, street lights.
- 7) Lock Lane is heavily used, particularly after the construction of the footbridge over the canal, as a major pedestrian route from the large Woodloes Park Housing estate.
