All references, unless otherwise stated, are to documents held by the County Record Office.

1) The passage from the The Butts (the Tink-a-Tank) to St Marys churchyard is presumed to have replaced the path from the Priory to St Marys which was closed in 1336 (Z251 f.xxii (original at Public Record Office under E164/VR22))

2) Town Map of 1610 by John Speed (published by the County Council as part of a teaching archive): shows the passage from The Butts.

3) Town Map of 1711: as above

4) 1786 Estate Map of whole of Warwick (CR1886/M32): shows passage from The Butts (no parcel number)

5) Sketch map of 1790, showing widths of streets, by Henry Couchman (surveyor) (QS24/578/15) : shows passage, but with line across The Butts end. No width given.

6) 1806 Estate map of whole town: labels path from The Butts as "passage" and shows paths around both sides of churchyard.

7) Deeds for 12 Church Street (CR1618/W4/11) 1741-1850:

1771: St Marys churchyard on north

1820: plan shows line of trees in churchyard separating strip beside house, with end of passage labelled "The Tink a Tank" 1846: plan shows and labels St Marys churchyard, with line of trees, and "Tink a Tank"

8) Tithe Map of St Marys parish 1848 (CR569/252): shows passage from The Butts, with paths around both sides of churchyard, coloured as with all other roads, but with lines across Church Street and Northgate Street ends

9) 1851 Board of Health Map: labels passage from The Butts as "Tinker Tank", and shows paths around both sides of churchyard - with gate features at The Butts and all three entrances to the churchyard (the existing gates are all similar in design and suggest one ownership)

10) route from The Butts to Church Street shown as adopted/maintainable on Highway Authority plans.

11) newspaper advertisement for temporary closure of the route published c.1995

12) the route from The Butts to Church Street has standard street lights and service covers. This implies the route is public since public services cannot normally be installed under private routes.
