All references are to documents held by the County Record Office.

1) The route probably forms part of the path from the Priory to St Marys church, part of which was extinguished in 1336 (Z251/1 f.xxii - original document at Public Record Office under E164/VR22)

2) Town Map of 1610 by Speed (published as part of teaching archive): shows link between The Butts and Priory Road/Chapel Street

3) Town Map of 1711: shows same route

4) 1786 Estate Map (CR1886/M32): shows path, with no parcel number [is therefore not part of a piece of land, but is part of the highway network]

5) map of streets in town centre 1790 by Henry Couchman (surveyor) (QS24/578/15): is a sketch map with all main streets labelled with their widths. This route is shown, with no barriers, but with no width (presumably since it was a footpath, not a road). The map also shows a proposed road diversion at Barrack Street/Joyce Pool.

6) 1806 estate map of town: shows passage, with no barriers

7) Tithe Map of St Marys 1848 (CR569/252): route is shown coloured in same way as all other roads, and with no dividing line separating it from the adjoining roads.

8) 1851 Board of Health Map: shows route with spot height on it

9) Route shown on all Ordnance Survey maps.

10) The path is paved with old blue bricks, which have been well maintained.

11) Official name plate at The Butts end.

12) Whole of route shown as adopted/maintainable on Highway Authority plans.

N.B. Form B has not been completed since the owner is not known.
