- ◆ Evidence - documents, plans, photographs (if applicable)

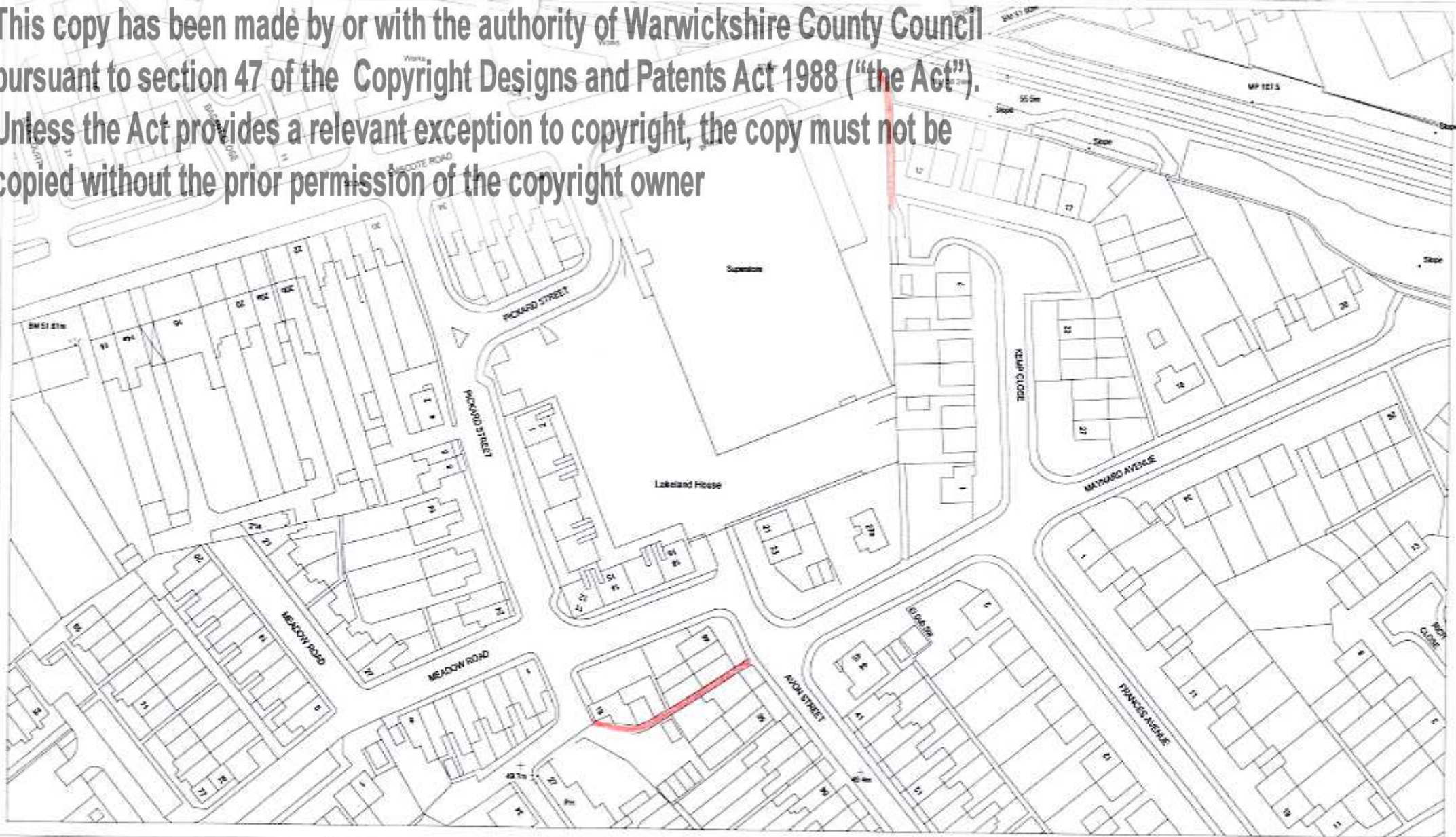
Route: 2 sections of path between Emscote Road and Pickard Street

Evidence

All references are to documents held by the County Record Office.

- 1) Warwick (St Nicholas) Inclosure Award 1773 (QS75/123): created whole route of path between present Pickard Street and Emscote Road (opposite Charles Street). Path specified to be 4 ft wide. This is, therefore, a legal event.
 - 2) Birmingham and Oxford Junction Railway deposited plan 1845 (QS111/153): shows route of original path - item 72: "public footway" owned by the Surveyor of Highways + John Stephenson. [The route was diverted on construction of the railway to emerge on to the Emscote Road by the railway bridge.] This is, therefore, a legal event.
 - 3) Extinguishment Order for section from Emscote Road to Avon Street 1860 (CR1618/WA6/107): withdrawn
 - 4) Extinguishment Order for section from Kemp Close to Maynard Avenue: confirmed 11 April 1985
 - 5) Extinguishment Order for section between Avon Street and Pickard Street to Magistrates Court 29 June 1989: not confirmed.
 - 6) Both sections have a well maintained tarmac surface.
 - 7) Both remaining sections are shown on the Highway Authority records as adopted/maintainable.
- N.B. Form B has not been completed since the owner is not now known.
