Statement of Evidence

- 1) The land forming the line of this path was purchased by the County Council in the late 1960's, the land being taken from the fields adjoining the road. This was specifically to create a safe pedestrian route from the Chesford crossroads to the junction with the road to Ashow due to the dangerous state of the main road which, even at that time, had no space to construct a footway within the existing highway boundaries.
- 2) The strip of land was then fenced off and a tarmac surface provided the whole length of the route, the route being shown, and labelled as "path", on the 1971 edition of the 1/2500 Ordnance Survey map.
- 3) The path has subsequently been used by the public, including by our local Mid-Warwickshire Group, although occasional problems of lack of maintenance have had to be reported.
- 4) There are many recorded cases of paths just inside the edge of fields over the hedge from a carriageway, with a number being shown on various estate maps and even being awarded in Inclosure Awards.
- 5) It is considered, therefore, that this is a public footpath which should be shown on the Definitive Map.
