### Statement of Evidence

- 1) This route forms the missing link between path SD312, in Hampton Lucy parish, and the accepted road at Wasperton House. The fact that SD312 is already recorded on the Definitive Map, and is shown on the Ordnance Survey maps as continuing out of the parish, clearly implies that the remainder of the route, in Wasperton, must also be public since the route does not stop as a particular public place.
- 2) The route is shown on the 1<sup>st</sup> edition of the Ordnance Survey one inch to one mile map of 1831 as an integral part of the road network, crossing the river by way of the ford labelled and shown on later maps.
- 3) The Tithe Apportionment map of 1841 for Wasperton (County Record Office CR569/256) also shows the route as part of the road network. It is identified on the map as parcel 219 and is described in the Book of Reference, under "Roads and Wastes", as "Ford Lane and waste at the River Avon". It comprised 1 rood 13 perches and, as with all the other roads accepted by the Highway Authority, was not liable to tithes.
- 4) The route is shown on all subsequent Ordnance Survey maps, up to the present day.
- 5) The route is shown as being excluded from the adjoining hereditaments on the maps prepared under the 1910 Finance Act thereby showing that it was outside those ownerships and part of the highway network.
- 6) The road does not form part of the adjoining land ownership, as demonstrated by the ownership information on planning applications.
- 7) The route has been used by the public and 5 statements from elderly residents, all obtained in 1977, support this claim. (See RA refs. I43 to I47)
