I hereby apply for an Order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the Definitive Map and Statement for the County of Warwick by **Adding** the following route as a -

Description :

Access to this walk is at the north corner of the Recreation Ground [A] by the cricket nets. This leads into the woods behind Waller Close. It then follows an earthen path approximately 1metre wide through the wood northwest until the brook is reached. The south bank of the brook is followed through the wood in a westerly direction until a road bridge is reached.

The walk passes under the bridge to pick up a smaller path approximately 1/2metre wide which follows the south side of the brook until a stone bridge is reached. The walk turns right over the bridge and the left to follow the north bank of the brook until it reaches the lakes and overflow, northwest of the Police Headquarters. The lakes are passed on their northern edge on a small path used by fishermen until a wooden bridge is reached. The walk crosses this bridge and leads on through a gap in the fence to link up with Public Footpath W179A at [B].

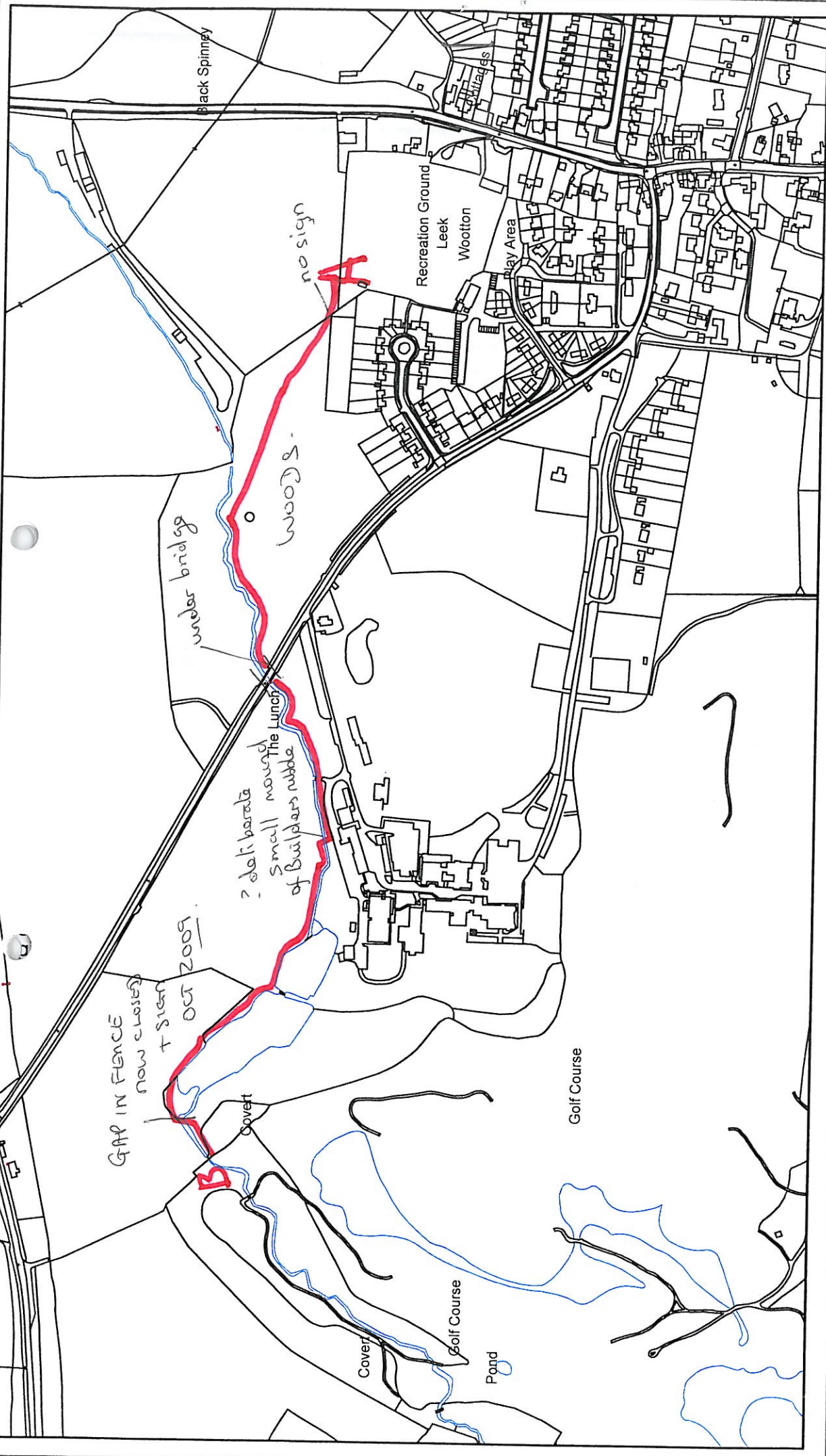

Until October 2002 there were no signs or obstructions preventing the use of this route.

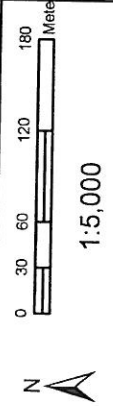
~~Until~~ In fact the fence at the end of the walk has only just been removed.
