Access to this walk is at the north corner of the Recreation Ground [A] by the cricket nets. This leads into the woods behind Waller Close to pick up a mud path approximately 1metre wide. From here the walk curves northwest through the wood and across the brook to pick up another path, again approximately 1metre wide, which then curves to the west and exits the wood through a large opening onto Woodcote Lane [B].




Until October 2008 there were no signs preventing the use of this route.
