

NOTICE OF MODIFICATION ORDER

Section 53 of the Wildlife and Countryside Act 1981

WARWICKSHIRE COUNTY COUNCIL

The Definitive Map and Statement for the County of Warwickshire 1998

The Warwickshire County Council Definitive Map Modification Order
Parish of Radford Semele Sheet SP36SE

Order No. 1 2014 Section of Path No. W123

The above Order made on 17 December 2014, if confirmed as made, will modify the Definitive Map and Statement for the area by:

- 1) Deleting from them the full width of the section of Public Footpath W123, in the District of Warwick and the Parish of Radford Semele, shown as a broken red line between points A and B on plan reference W123/MEB/OrderPlan1 annexed hereto.

It starts from its junction with Public Footpath W122c labelled point A (grid reference SP 35106414). It runs generally north east for approximately 165 metres to its junction with A425 Southam Road labelled point B (grid reference SP 35226425)

AND

- 2) A section of Public Footpath, W123, in the District of Warwick and the Parish of Radford Semele, to be added, shown as a solid purple line between points A and C on plan reference W123/MEB/OrderPlan-1 annexed hereto.

It starts from its junction with Public Footpath W122c labelled point A (grid reference SP 35106414). It runs generally east north east for approximately 193 metres to its junction with A425 Southam Road labelled point C (grid reference SP35276423).

The width of the route is 1.2 metres. The surface is unmade.

Any representation or objection relating to the Order must be sent in writing to the Strategic Director, Communities Group, Warwickshire County Council, Shire Hall, Warwick, CV34 4SX to arrive no later than 30 January 2015, and applicants are requested to state the grounds on which it is made.

If no representations or objections are duly made to the Order, or any part of it, or if any so made are withdrawn, the Warwickshire County Council, instead of submitting the Order to the Secretary of State, may itself confirm the Order. If the Order is submitted to the Secretary of State for the Environment, in whole or in part, any representations and objections which have been duly made and not withdrawn will be sent with it.

This Order is made by Warwickshire County Council under Section s53(2)(a) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the authority that the Definitive Map and Statement for the County of Warwickshire 1998 require modification in consequence of an event specified in:

Section 53 (3)(c)(iii) and Section 53(3)(c)(i) of the Act:

that there is no public right of way over land shown in the map and statement as a highway of any description, or any other particulars contained in the map and statement require modification;

and

that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic.

The authority have consulted with every local authority whose area includes the land to which the Order relates. The Warwickshire County Council hereby order that:

1. For the purposes of this Order the relevant date shall be 1 November 2014.
2. The Definitive Map and Statement for Warwickshire 1998 Sheet SP36SE shall be modified as described in Part I and II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the Warwickshire County Council Definitive Map Modification Order, Parish of Radford Semele, Sheet SP36SE, Order No. 1 2014, Section of Path No. W123.

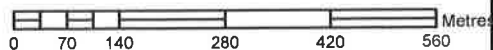
