PUBLIC PATH DIVERSION ORDER 2012

On 18 March 2015, Warwickshire County Council confirmed the above Order made under section 119 of the Highways Act 1980.

The effect of the Order as confirmed is to **DIVERT** that section of public footpath M421 from Point A being approximately 120 metres north north east of Hall Farm (grid reference 42602 29219), running in a general south-south-west direction for approximately 195 metres to Point B (grid reference 42597 29201) as shown on the Order Plan. TO A LINE from Point B at Hall Farm (grid reference 42597 29201), running in a general north-north-easterly direction for approximately 90 metres to Point C (grid reference 42603 29207) thence generally north for approximately 120 metres to Point D (grid reference 42604 29220) as shown on the Order Plan. DIVERT that section of Public Footpath M421 from Point E at Hall Farm (grid reference 42598 29197). running in a general south westerly direction for approximately 340 metres to Point G (grid reference 42572 29176) thence generally west-south-west for approximately 195 metres to Point H (grid reference 42554 29172) as shown on the Order Plan. TO A LINE from Point E at Hall Farm (grid reference 42598 29197), running in a general south-south-easterly direction for approximately 65 metres to Point I (grid reference 42601 29191) as shown on the Order Plan. **DIVERT** that section of Public Footpath M423a from Point J at Hall Farm (grid reference 42582 29198), running in a general easterly direction for approximately 160 metres to Point L (grid reference 42597 29199) as shown on the Order Plan. TO A LINE from Point J at Hall Farm (grid reference 42582 29198), running in a general south-south-easterly direction for approximately 195 metres, crossing a watercourse at Point F (grid reference 42590 29185), to Point K (grid reference 42593 291827) as shown on the Order Plan. DIVERT that section of Public Footpath M424 from Point G being approximately 400 metres west of Sandy Lane (grid reference 42572 29176), running east for approximately 10 metres to Point M (grid reference 42573 29176) as shown on the Order Plan. TO A LINE from Point H being approximately 220 metres east of Sandy Lane (grid reference 42554 29172), running in a general eastnorth-easterly direction for approximately 195 metres to Point M (grid reference 42573 29176) as shown on the Order Plan. The new paths will have a width of 2 metres.

A copy of the Order and the Order Plan have been placed and may be seen free of charge at the offices of Warwickshire County Council, Shire Hall, Market Square, Warwick CV34 4SA from 8am - 5.30pm on weekdays, (5pm Fridays) and 9am - 4pm Saturdays. The Order comes into force on 26 March 2015, but if a person aggrieved by the order wants to question its validity, or that of any provision contained in it, on the ground that any requirement of the Act, as amended, or if any regulation made under the Act has not been complied with in relation to the order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from [19 March 2015], make an application to the High Court.

This Order is made by Warwickshire County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpaths described in paragraph 1 of this Order it is expedient that the line of the path should be diverted.

Mr R N Varnam has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

North Warwickshire Borough Council has been consulted as required by section 120(2) of the 1980 Act;

BY THIS ORDER:

- 1. The public right of way over the land situate at **Over Whitacre** and shown by a bold continuous line on the plan numbered P2008/021G contained in this Order ('the Order Plan') and described in Part 1 of the Schedule to this Order shall be stopped up upon written certification that all of the works to implement the Order have been satisfactory completed.
- 2. There shall at the end of 7 days from the date of confirmation of this Order be public footpaths over the land situate at **Over Whitacre** described in Part 2 of the Schedule and shown by bold broken lines on the Order Plan.
- 3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

PART 1 DESCRIPTION OF SITE OF EXISTING PATH OR WAY

Public Footpath M421

Between Points A and B on the Order Plan

That section of Public Footpath M421 from Point A being approximately 120 metres north-north-east of Hall Farm (grid reference 42602 29219), running in a general south-south-west direction for approximately 195 metres to Point B (grid reference 42597 29201) as shown on the Order Plan.

Public Footpath M421

Between Points E-G-H on the Order Plan

That section of Public Footpath M421 from Point E at Hall Farm (grid reference 42598 29197), running in a general south westerly direction for approximately 340 metres to Point G (grid reference 42572 29176) thence generally west-south-west for approximately 195 metres to Point H (grid reference 42554 29172) as shown on the Order Plan.

Public Footpath M423a

Between Points J and L on the Order Plan

That section of Public Footpath M423a from Point J at Hall Farm (grid reference 42582 29198), running in a general easterly direction for approximately 160 metres to Point L (grid reference 42597 29199) as shown on the Order Plan.

Public Footpath M424

Between Points G and M on the Order Plan

That section of Public Footpath M424 from Point G being approximately 400 metres west of Sandy Lane (grid reference 42572 29176), running east for approximately 10 metres to Point M (grid reference 42573 29176) as shown on the Order Plan.

PART 2 DESCRIPTION OF SITE OF NEW PATH OR WAY

Public Footpath M421

Between Points B-C-D on the Order Plan

From Point B at Hall Farm (grid reference 42597 29201), running in a general north-north-easterly direction for approximately 90 metres to Point C (grid reference 42603 29207) thence generally north for approximately 120 metres to Point D (grid reference 42604 29220) as shown on the Order Plan.

The new path shall have a width of 2 metres.

Public Footpath M421

Between Points E and I on the Order Plan

From Point E at Hall Farm (grid reference 42598 29197), running in a general south-south-easterly direction for approximately 65 metres to Point I (grid reference 42601 29191) as shown on the Order Plan.

The new path shall have a width of 2 metres.

Public Footpath M423a

Between Points J-F-K on the Order Plan

From Point J at Hall Farm (grid reference 42582 29198), running in a general south-south-easterly direction for approximately 195 metres, crossing a watercourse at Point F (grid reference 42590 29185), to Point K (grid reference 42593 291827) as shown on the Order Plan.

The new path shall have a width of 2 metres.

Public Footpath M424

Between Points H and M on the Order Plan



The new path shall have a width of 2 metres.
