

NOTICE OF CONFIRMATION OF AN ORDER

HIGHWAYS ACT 1980

WARWICKSHIRE COUNTY COUNCIL

(PART OF FOOTPATH M449 OVER WHITACRE) PUBLIC PATH EXTINGUISHMENT ORDER 2013

On 20 May 2015, Warwickshire County Council confirmed the above Order made under section 118 of the Highways Act 1980.

The effect of the Order as confirmed is to **EXTINGUISH** the full length of public footpath M449 from Point A on the B4114 Coleshill Road (grid reference 42487 29128) running generally east for approximately 140 metres to Point B on the B4114 Nuneaton Road (grid reference 42501 29129) as shown on the Order Plan.

A copy of the Order and the Order Plan have been placed and may be seen free of charge at the offices of Warwickshire County Council, Shire Hall, Market Square, Warwick CV34 4SA from 8am - 5.30pm on weekdays, (5pm Fridays) and 9am - 4pm Saturdays. A copy of the Order and Order Plan may be bought there at the price of £5.55. The Order come into force on 20 May 2015, but if a person aggrieved by the Order wants to question it's validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 21 May 2015 make an application to the High Court.

The public right of way over the land situate at **Over Whitacre** shown by a continuous bold line on the plan numbered P2009/009G attached to this Order ('the Order Plan') and described in the Schedule to this order shall be extinguished after 7 days from the date of confirmation of this Order.

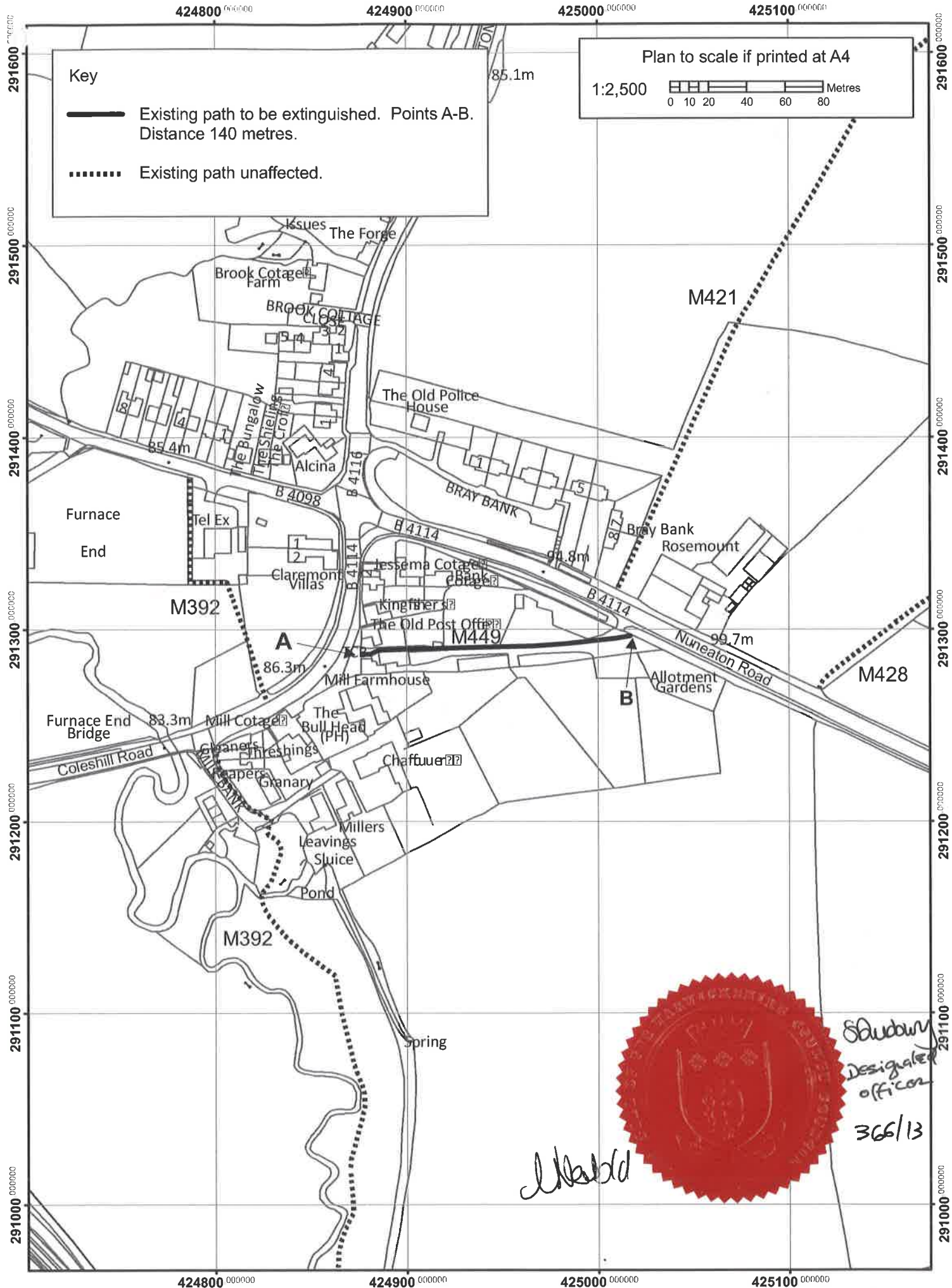
