This Order is made by Warwickshire County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the bridleway described in paragraph 1 of this Order it is expedient that the line of the path should be diverted.

Mrs KN and SL Righton c/o Plumtree, Brailes has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Stratford District Council has been consulted as required by section 120(2) of the 1980 Act;

BY THIS ORDER:

- 1. The public right of way over the land situate at **Brailes** and shown by a bold continuous line on the plan numbered P2010/010G contained in this Order ('the Order Plan') and described in Part 1 of the Schedule to this Order shall be stopped up after 7 days from the date of confirmation of this Order
- 2. There shall at the end of 7 days from the date of confirmation of this Order be a public bridleway over the land situate at **Brailes** described in Part 2 of the Schedule and shown by a bold broken line on the Order Plan.
- 3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

SCHEDULE

PART 1 DESCRIPTION OF SITE OF EXISTING PATH OR WAY Between Points A and B on the Order Plan

That section of Public Bridleway SS63a from Point A (grid reference 43290 23733), running generally northeast for approximately 35 metres, then south south east for approximately 75 metres, then east for approximately 90 metres to Point B (grid reference 43306 23728) as shown on the Order Plan.

PART 2 DESCRIPTION OF SITE OF NEW PATH OR WAY Between Points A-C and B on the Order Plan

From Point A (grid reference 43290 23733) running generally south east for approximately 80 metres, then south south east for approximately 60 metres to a culvert at Point C (grid reference 43299 23722), then generally north east for approximately 95 metres to Point B (grid reference 43306 23728) as shown on the Order Plan.


The new route shall have a width of 3 metres.
